WHEREAS the Trustees of the Salterhebble, Stainland, and Sowerby Bridge Turnpike Road, acting under the powers of the Local Act of the last of Victoria, cap. 42, have made application to Her Majesty's Principal Secretary of State for the Home Department, pursuants to the Act of the Session holden in the 14th and 15th years of the reign of Her present Majesty, cap. 38, for a Provisional Order to reduce the rate of interest on the mortgage debt charged or secured on the tolls or revenues of the said road, and to extinguish the whole of the arrears of interest due upon And whereas the said application is dated

the fourteenth day of June, one thousand eight hundred and sixty six, and is signed by three of the said trustees, who therein certify that the persons entitled to two-thirds of the money charged or secured on the tolls of the said road and remaining unpaid, have signified their consents in writing under their hands to the said application ;

And whereas it appears desirable to Her Majesty's Principal Secretary of State for the Home Department that the aforesaid application should be granted upon the terms herein set forth ; .......

"Now, therefore, in pursuance of the power and authority of the said Act of the 14th and 15th of Victoria, cap. 1:38, given to me, as one of Her Majesty's Principal Secretaries of State, and in conformity with the said application, I do by this Provisional Order under my hand declare,-subject to the confirmation hereof by Parliament,that from the thirty-first day of December, one thousand eight hundred and sixty-five, the rate of interest shall be reduced from five pounds to: four pounds per centum per annum upon the bonded or mortgage debt of seven thousand one hundred and fifty-four pounds, three shillings and four pence, charged or secured upon the tolls

3. Discharged Soldiers applying personally must produce their Parchment Certificate of Service and Regimental Account Book, or Parchment Certificate of Pension.

4. Pensioners residing in the country should apply through the Staff Officer of Pensioners for the District in which they respectively reside.

5. Claimants to the Shares of Deceased Soldiers, and all Claimants, Officers or Soldiers, residing beyond 5 miles from Chelsea Hospital, must apply by letter, addressed to "The Secretary of Chelsea Hospital;" when the necessary Forms will be sent.

6. Discharged Soldiers, as also all claimants on account of Deceased Soldiers, must state distinctly in their letters, the Name in full, the Regiment in which he served at the time of the capture, and the Regimental Number of the man on whose account the claims are preferred.

Observe-The claims preferred are so numerous, that it is found impossible to examine them, except after some delay. They will be investigated as early as possible, and in the order of date in which they are received, and an answer will be sent without the necessity of again applying on the subject.

A great portion of the delay is occasioned by the unnecessary renewal of the several applications.
