THE Queen has been pleased to appoint Rear-Admiral Charles George Edward Patey to be Administrator of the Government of the Settlement on the Gambia, and Commander John Hawley Glover, R.N., to be Administrator of the Settlement of Lagos on the Western Coast of Africa.

By virtue of an Act passed in the twenty-second year of the reign of Her Most Gracious Majesty, Queen Victoria, intituled "An Act to "extend the Act of the twenty-fourth year of "King George the Third, chapter twenty-six, for issuing writs during any recess of the House of "Commons, whether by prorogation or adjourn-ment;" and of an Act passed in the twenty-sixth year of the reign of Her present Majesty, intituled "An Act to further limit and define the "time for proceeding to Election during the "Recess."

I do hereby give notice, that it hath been certified to me in writing, under the hands of two Members serving in this present Parliament, in the manner required by the said Act, that John George, Esq., late a Member serving in this present Parliament, for the county of Wexford, hath accepted the office of one of the Judges of Her Majesty's Court of Queen's Bench in Ireland, and has been gazetted thereto in the Dublin Gazette dated the 19th day of October, 1866, and has thereby vacated his seat; and that I shall issue my warrant to the Clerk of the Crown, to make out a new writ for the electing of a Member to serve in this present Parliament for the said county, at the end of six days after the insertion of this notice in the London Gazette.
