AT the Council Chamber, Whitehall, the 30th day of October, 1866.

By the Lords of Her Majesty's Most Honourable Privy Council.

PRESENT,

Mr. Secretary Walpole. Mr. Corry. Mr. Cave.

W HEREAS by an Order bearing date the 24th day of March, 1866, duly issued under the authority of an Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, intituled "An Act to prevent, until the first "day of September, one thousand eight hundred "and fifty, and the end of the then session of Par-"liament, the spreading of contagious or infectious disorders among sheep, cattle, and other animals," and from time to time continued by divers subsequent Acts, and lastly by an Act of the last session, which Order recited that a contagious or infectious disorder, generally designated as the "Cattle Plague," prevailed amongst cattle in England and Wales, the Lords of the Council made various regulations for preventing the spread of the said cattle plague, and among others, for dealing with infected places:

And whereas it is provided in the said regulations that any Local Authority as to any place within its district should, by their order made at any time after the passing of the said Order of the 24th day of March, and published in manner therein mentioned, declare any place in which disease amongst animals at that time existed, together with such an area including such place as to such Authority might seem to be required, to

be an infected place, from and after a date to be specified in such Order of the Local Authority:

And whereas it was further provided in the said regulations of the said Order of the 24th day of March, that the Authority declaring a place to be infected might, at the expiration of one month after the disappearance of the disease in that place by order published in like manner, declare such place to be free from the disease, and after the publication of such order such place should cease to be an infected place within the meaning of the said Order of the 24th day of March:

And whereas the Justices of the Peace of the county palatine of Chester, in Quarter Sessions assembled, being the Local Authority for that county, did, by an order, bearing date the 13th day of April, 1866, duly made, declare the whole of the said county, excepting only the petty sessional division of Hyde and the borough of Stockport, to be an infected place, and such order was duly published in the manner prescribed by the above mentioned Order of the 24th day of March:

And whereas the said disease has ceased in many parts of the said place so declared to be infected, but not in the whole of it; and it is considered that the said Local Authority cannot make an order to declare any parts of the said place free from disease, so as to give effect therein to the provisions of the said Order of the 24th day of March, applicable to places declared to be free from disease, and it is advisable that the said Order should be altered in this respect, as herein provided:

Now, therefore, the Lords of Her Majesty's Privy Council do hereby order that, from and after the thirtieth day of October instant, the said Local Authority for the county palatine of Chester may declare the following parts and places of the place so declared to be infected as aforesaid, or

any portions thereof, to be free from disease; that is to say:—

The Stockport, Eddisbury, Nantwich, and Wirral Petry Sessional Divisions of the said

Such portion of the Broxton Petty Sessional Division as lies to the north and west of the road leading from Wrexham, through Malpas and Bickerton, to Bulkeley;

and thereupon such places shall cease to be infected places within the meaning of the said Order, unless again declared to be infected in manner aforesaid.

Every such order so to be made by the Local Authority shall be published in the manner, described in the said Order of the 24th day of March, in reference to infected places, and a copy thereof shall be forthwith transmitted by the Local Authority to the Privy Council.

This Order shall be published in some newspaper circulating in the county of Chester, and shall be construed in like manner as the said Order of the 24th day of March last; and all the provisions therein contained, so far as they may be applicable, shall apply to this Order.

THEREAS by an Order of Her Majesty's VV Privy Council, bearing date the 24th day of March last, duly issued under the authority of the Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, intituled "An Act to prevent, "until the first day of September, one thousand "eight hundred and fifty; and to the end of the " then session of Parliament, the spreading of con-"tagious or infectious disorders among sheep, "cattle, and other animals," and from time to time continued by divers subsequent Acts, which Order recited that a contagious or infectious disorder, generally designated as the "Cattle Plague," prevailed amongst cattle in England and Wales, the Lords of Her Majesty's Privy Council did make various regulations for preventing the spread of the cattle plague, and did, amongst other things, order that no market, fair, auction, exhibition, or sale of cattle should be field until the 1st day of June, 1866, except as otherwise provided; and by an Order of the said Lords bearing date the 26th day of May last, the said regulation was continued until the said Lords should otherwise order:

And whereas it is advisable that the said regulation should be altered as regards the county of Glamorgan in the manner hereinafter provided:

Now, therefore, the Lords of Her Majesty's Privy sand eight hundred and sixty-six, notwithstatiding Council do hereby order, that the Local Authority anything in the first-mentioned Order of the in the county of Glamorgan may grant licences for 31st day of August 1866 provided, it shall be

the holding of fairs whereat cattle may be sold, so that a separate licence be granted for every fair, and that the same shall be revocable at the discretion of the said Local Authority, and be in writing, and in such form as the Local Authority shall deem to be expedient: and at any fair, held under such licence, cattle may be sold, anything in the said Order to the contrary notwithstanding.

This Order shall be construed in like manner as the said Order of the 24th day of March last, and all the provisions therein contained shall apply to this Order, so far as the same shall be applicable.

WHEREAS by an Order bearing date the 31st day of August last, duly issued under the authority of the Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, the Lords of Her Majesty's Privy Council did, amongst other things, order that from and after the 3rd day of September, 1866, it should not be lawful for any person to remove cattle or other animals from any port or place in England and Wales to any port or place in Scotland:

And whereas, by an Order bearing date the 10th day of September, 1866, the said Lords did order that, notwithstanding anything in the above mentioned Order provided, it should be lawful for any person to move rams from the county of Northumberland into Scotland, provided that a licence for moving such rams were obtained in the form and otherwise in accordance with the provisions contained in the Order made by the Lords of Her Majesty's Privy Council bearing date the 8th day of August, which apply to the store stock licence, and provided also, that the Local Authority of the county in Scotland into which such rams are proposed to be moved, should give authority or issue any regulations for the movement of rams from the county of Northumberland into it; and by a further Order bearing date the 2nd day of October, 1866, they did extend the provisions of the last-mentioned Order of the 10th day of September to sheep and lambs proposed to be moved from the county of Northumberland into Scotland:

And whereas it is expedient that the provisions of the said Orders of the 10th day of September and 2nd day of October, 1866, should be further extended:

Now, therefore, the Lords of Her Majesty's Privy Council do hereby erder, that from and after the first day of November, one thousand eight hundred and sixty-six, notwithstatiding anything in the first-mentioned Order of the 31st day of August 1866 provided, it shall be

lawful for any person to move cattle and other animals from the counties of Northumberland and Cumberland into Scotland; provided that a licence for moving such animals be obtained in the form and otherwise in accordance with the provisions contained in the Order made by the Lords of Her Majesty's Privy Council bearing date the 8th day of 'August, which apply to the store stock licence; and provided also, that the Local Authority of the county in Scotland into which such animals are proposed

to be moved shall give authority or issue any regulation for the movement of animals from the county of Northumberland or Cumberland into it.

And the said Lords do further order, that every such regulation so to be made by the said Local Authority shall be published in the same manner as other regulations of the said Local Authority have been hitherto published under the directions of the Lords of the Council.
