Saint Leonard, Eastcheap, and of the dean and chapter of the said last named cathedral church the other alternate patrons of the said last named rectory (testified by the said chapters respectively sealing this supplemental scheme with their several corporate seals), and with the consents of the vestry of the said parish of All Hallows, Lombard-street, and of the joint vestry of the said united parishes of Saint Benet, Gracechurch, and Saint Leonard, Eastcheap (testified by the respective chairmen of the said vestry and joint vestry respectively signing this supplemental scheme, pursuant to resolutions passed at a vestry and joint vestry respectively duly convened for the purpose of giving such consents), we humbly recommend and propose, that we may be authorized and empowered upon the union of the said benefices of All Hallows, Lombard-street, and Saint Benet, Gracechurch, with Saint Leonard, Eastcheap, taking effect, as provided by the hereinbefore mentioned Order of your Majesty in Council, bearing date the first day of November, in the year one thousand eight hundred and sixtyfour, to sell and dispose of, by means of tender or by private contract, or in such other way as shall appear to us to be most fitting, not being by public auction, and so nevertheless as to obtain a fair and reasonable price for the same, the materials and site of the said church of Saint Benet, Gracechurch (when the same shall have been taken down, as provided by the said Order of your Majesty in Council), and also the pulpit, bells, clock, organ, and other furniture and fittings (other than the font, communion table and plate), if the same should not be required and appropriated to and for the intended new district at Stepney, to be called "The District of Saint Benet, Stepney," as hereinbefore mentioned. "And we further recommend and propose, that

nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinmentioned Act, or of any other Act of Parliament."

And whereas the said supplemental scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said supplemental scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

WHEREAS by "The West Indian Incum-VV "bered Estates Act, 1854," provision was made to facilitate the sale and transfer of incumbered estates in the several West Indian Colonies named in a schedule to the said Act (among which is the colony of Grenada), and it

time, by Order in Council, direct the said Act to come into operation in any of the said colonies, but that no such Order in Council should be made in respect of any colony until the Legislature thereof should have presented an Address to Her Majesty, praying Her Majesty to issue such Order, and should also have made provision, to the satisfaction of Her Majesty's Principal Secretary of State for the Colonies, for the payment of the salaries of the Local Commissioners in the said Act mentioned, and of all such assistant secretaries, clerks, messengers, and officers, as might be appointed under the said Act in such colony, and of such other expenses of carrying the said Act into execution as were therein directed to be provided for by the said Legislature:

And whereas other Acts have passed, intituled respectively "The West Indian Incumbered Estates Act, 1858," "The West Indian Incumbered Estates Act, 1862," and "The West Indian Incumbered Estates Act, 1864; "and whereas by the said several Acts respectively it is provided that when Her Majesty shall, by Order in Council, direct that the said first-mentioned Act shall come into operation in any of the colonies mentioned therein, such Order shall be construed to apply as well to the said several Acts as to the said firstmentioned Act:

And whereas the Legislature of Grenada, by an Address, dated the eighteenth day of July, one thousand eight hundred and sixty-six, has prayed Her Majesty to issue such Order aforesaid, and by an Act dated the sixteenth day of August, one thousand eight hundred and sixty-six, intituled "An Act for carrying into execution, in the "Island of Grenada and its dependencies, 'The "' West Indian Incumbered Estates Acts, 1854, "' 1858, 1862, and 1864," has made provision for the payment of such salaries and other expenses as aforesaid, to the satisfaction of Her Majesty's Principal Secretary of State for the Colonies.

It is, therefore, hereby ordered by the Queen's Most Excellent Majesty, by and with the advice of Her Privy Council, that the said "West Indian Incumbered Estates Act, 1854," shall, from the date of this Order in Council, come into operation in the colony of Grenada.

And the Right Honourable the Earl of Carnarvon, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions accordingly.
