

gotski being under his Imperial Majesty's Tutelage, shall continue with them to whose Care it shall be thought fit to commit them. XI. It is not allow'd to send to *Teckley* for his Consent to yield up the place, or to justify the doing it, he being look'd upon as a Person dead in Law. XII. It is free for every one to return to their respective Homes, with their Goods and Provisions: But there being a scarcity of Carriages, every one must provide in that particular for himself, only there will be a Provision made for the Princess of as many Carriages as are convenient for her use. XIII. That the Acceptance of these Articles, without Reply or Amendments, be signified by to morrow morning ten of the Clock; and that such, and as many, Hostages be then sent as shall be required, who shall bring a full Consent in Writing to what is now offer'd; and that upon their coming out of the Town, the Imperial Commissioners shall be received into it; and the Imperial Garrison shall be admitted to march in by 12 of the Clock; and at the same time the Persons of Quality and Soldiers shall remove out of the Castle into the Palace, only the Princess may continue still there with her Children and Servants, till such time as she can prepare for her Journey. XIV. Every individual Article shall be religiously observed by the Princess, her Children, and all others concern'd; and in case of Contravention, this Agreement shall cease as to the Breakers of it. XV. It is not necessary that his Imperial Majesty's Ratification be expected, since he has given Count *Caraffa* full Power and Authority, to accept their Surrender, in his Majesty's Name; upon such Conditions as he shall think fit to admit, which he now offers on the Word of a Gentleman, and the Faith of a Christian. Given in the Camp before *Mongatz*, the 24th Day of *January*, 1688. When these Articles were brought to the Princess, and advised upon, she found the Necessity she was under to comply with them, which yet she did not do without publicly bewailing her hard Fate, which constrain'd her to Sign, as it were, the Sentence of Death against her Husband, for that the Forelaw must be the consequence of what she was about, as being assured the Turks would revenge upon his Person their Disappointment in the loss of that place. The Conditions were executed according to the Tenor of them, on both sides. There was in the place but 480 Men able to bear Arms, besides the Princess's Family, and some few who had retired thither for Protection; they had Provisions left sufficient for 3 Months. All things considered, this is reckoned the strongest place in all *Hungary*; the strength of it consists in Three Castles upon a Hill, where there is nothing to command them, surrounded with a Ditch hewn out of a Rock; and round the Foot of the Hill is another large and deep Ditch fill'd with Water. The place was not to be formally besieged, but by a numerous Army; the Approaches to it must have been very dangerous, there being no natural Shelter, and scarce any was to be made by Art, by reason of the hardness of the Soil, so that it was not to be attack'd but by the loss of much time and many Men; yet such is the good Fortune of the Emperor, that he hath recovered this Important place, by employing no more against it than 2000 Men only, who continued the Blockade under the command of Major-General Count *Terzi*.

Ratisbonne, Febr. 5. The Elector of *Bavaria*, though he was invited to pass the Carneval at *Vienna*, is gone for *Venice*; the Electress accompanied him as far as *Innsprach*, where she will continue with the Queen of *Poland* expecting his return. The design of this Journey is said to be, that the Elector may have an opportunity to confer Personally with the Prince of *Tuscany* about the Marriage of his Sister. It is said, That the Princess of *Oest Frize* is sending a Minister hither, to take care of the Interest of that Dutchy, upon the Elector of *Brandenburg's* late Demand of it, by his Memorial, for Satisfaction; and it is expected that the Sieur *Puffendorf* (who lately retir'd from the Service of the Swedes, in which he had been 30 Years employ'd, upon a Distaste he took at a Determination made in Favour of Baron *Welling* to his Prejudice,) is coming to reside here for the King of *Denmark*. It is advis'd from *Berlin*, That the Preliminary Treaty begun there between *Denmark* and *Holland*, (which was thought concluded,) is now like to break off.

Hamburgh, January 27. We do not hear as yet that the Duke of *Holstein* has made any Reply to the Danes Answer, and the reason of this delay may be the Death of the Sieur *Ulken*, one of the Duke's Commissioners, which hapned on the 23d Instant: He was a Person in repute to be very able, and one who was thoroughly inform'd in the whole State of this Controvercie, and who had no less Zeal and Affection for his Master's Person and Interest. In this the King of *Denmark* hath had the Advantage of the Duke of *Holstein*, that both their Ministers, upon whom the weight of the Negotiation lay, falling dangerously sick since the opening of this Treaty, the one is dead, and the Sieur *de Ehrenfeld*, the King's Commissioner, is perfectly recovered. It is not now doubted but that King intends to fortifie *Oldensloe*, and all due Preparations are making of Materials and Provisions for carrying on that Work. And they write from *Rensburgh*, that some Regiments are ordered to march thither for the Security of those employ'd about it. Lieutenant-General *Arndstorf* has been through this Country, to give all necessary Orders; and it is discour'd that his Majesty

will come in Person into *Holstein* towards Spring: And that great Preparations were making at *Copenhagen* to get a Fleet ready against the same time.

Plsmouth, Febr. 5. This day arriv'd in this Port the *Crown Frigate* from *Constantinople*, Captain *Newill* Commander; they pass'd by the *Dragon* in their return, and left Captain *Kilgrew* so well, that he was out of danger from his Wounds.

Whitehall, February 8. *Stephen Lynch* Esq; being Appointed, with His Majesty's Approbation, One of the Agents of Sir *Robert Holmes* His Majesty's Sole Commissioner for suppressing of Pirats in *America*, and having received particular Directions, amongst other things committed to his Trust, to carry His Majesty's late Proclamation in that behalf to *Jamaica*, and to the Spanish Ports as well on the North Sea as to *Panama* on the South Sea, being furnished with all necessary Passports from the Crown of *Spain*; After which he is to remain for the further performance of this Service, at *Jamaica*; His Majesty has been Graciously pleas'd to continue the place of Consul in *Flanders* unto the said Mr. *Lynch*, to be executed by his Deputy during his absence, as a Mark of His Majesty's Grace and Favor to him.
