LOCAL GOVERNMENT ACT, 1858.

Notice of Adoption of Act by New Malden (PART OF THE PARISH OF KINGSTON-UPON-THAMES), SURREY.

WHEREAS the Local Government Act, 1858, was duly adopted on the 10th day of September, 1866, by so much of the parish of Kingston-upon-Thames, in the county of Surrey, as is not comprised within the limits of the borough of Kingstonupon-Thames, nor within the limits and jurisdiction of the Surbiton Improvement Commissioners, such part of the said parish to be styled New Malden; and whereas notice of such adoption has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act; and whereas it has also been duly certified to me that a copy of such notice has been duly advertised, and that copies have also been affixed to the principal doors of the churches and chapels in such district to which notices are usually affixed, and a petition has been presented, praying for the separation of a part of such district, and evidence was adduced in support thereof, at the inquiry held by Mr. Morgan, the Inspector appointed by me for the purpose; and whereas such district is a place with a population of less than 3000 by the last census, but it has appeared to me that, by reason of the special circumstances of the case, it is expedient that the said district should be allowed to adopt the said
