NOTICE OF ADOPTION OF ACT BY THE TOWN OF BOGNOR, IN THE COUNTY OF SUSSEX.

WHEREAS the Local Government Act, 1858, was, on the 6th day of November, 1866, duly adopted by the Commissioners of the town of Bognor, in the county of Sussex, acting in the execution of an Act of Parliament made and passed in the fifth and sixth years of the reign of His late Majesty King William the Fourth, intituled "An Act for paving, lighting, watching, and otherwise improving the town of Bognor, in the county of Sussex, and for amending and enlarging [two Acts of Parliament passed in the third and sixth years of the reign of His late Majesty King George the Fourth, relating to the said Town," for the town and titling of Bognor; and whereas notice of such adoption has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act: and whereas it has now been certified to me that a copy of such notice has been duly advertised and published, as required by the said Act, and the period fixed for appeal against the resolution for the adoption of the said Act by Bognor has now expired, and no such appeal has been made:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby give notice, that the said Local Government Act, 1858, has been duly adopted within the limits of Bognor, within the jurisdiction of the Commissioners, as hereinbefore described, and that, in accordance with the provisions thereof, the said Act will, at the expiration of two months from the date of the passing of the aforesaid resolution, have the force of law therein.
