middle of the last-described road for a distance of six and a half chains or thereabouts, to a point opposite to the middle of the western end of the fence dividing the cottage and garden occupied by John Fuller, Esquire, and numbered 603 upon the said maps from the close numbered 604 upon the same maps, and extending thence eastward to and along the middle of the last-described fence to its eastern extremity, and continuing thence north-eastward to and along the middle of the stream called ' Boulter's Pound Cut' to its junction with the River Thames, and continuing thence still north-eastward along the middle of the said river as far as a point opposite to the northern end of the island adjoining 'Boulter's Lock' and extending thence in a direct line eastward to the county boundary on the eastern bank of the same river, which divides the said parish of Cookham from the parish of Taplow as aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore Her Majesty by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Oxford.

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners VV for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven; of the Act of the nine-teenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the twentyninth and thirtieth years of Her Majesty, chapter eighty-six, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirty-first day of January, in the year one thousand eight hundred and sixty-seven, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven: of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; and of the Act of the twenty-ninth and thirtieth years of your Majesty, chapter eighty-six, have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of All Saints, situate at Hamer, in the new parish of Saint John, Smallbridge, sometime part of the parish of Rochdale,

sometime part of the said parish of Rochdale, which lie contiguous one to another, and are described in the schedule hcreunder written, there is collected together a population which is situate at a distance from the several churches of such respective new parishes. "And whereas it appears to us to be expedient

that such contiguous portions of the said new parish of Saint John, Smallbridge, and of the said new parish of Saint James, Wardleworth, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of All Saints, situate at Hamer aforesaid.

"Now, therefore, with the consent of the Right Reverend James Prince, Bishop of the said diocese of Manchester, as such bishop, and also as prospectively, that is to say, after the next avoid-ance of the vicarage of the said parish of Roch-dale, the patron of the vicarage of the said new parish of Saint John, Smallbridge, and with the consent of the Reverend John Edward Nassau Molesworth, doctor in divinity, the present vicar or incumbent of the vicarage of the parish of Rochdale aforesaid, and as such the present patron of the vicarage of the new parish of Saint John, Smallbridge, aforesaid, and also the patron of the vicarage of the said new parish of Saint James, Wardleworth (in testimony whereof they have respectively signed and sealed this representation), we humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint John, Smallbridge, and of the said new parish of Saint James Wardleworth, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of All Saints, situate at Hamer as aforesaid, and that the same should be named 'The Consolidated Chapelry of All Saints, Hamer,' and that the right of presentation and appointment to the church of such consolidated chapelry should belong to and be exercised by the said James Prince, bishop of the said diocese of Manchester, and by his successors bishops of the same diocese

for ever. "We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order in respect thereto as to your Majesty in your Royal wisdom shall seem meet."

## The SCHEDULE to which the foregoing Representation has reference :--

"The Consolidated Chapelry of All Saints Hamer, being :-

"All that portion of the new parish of Saint John, Smallbridge, sometime part of the parish of Rochdale, in the county of Lancaster, and in the diocese of Manchester, which is situate to the south-west of an imaginary line commencing upon the boundary which divides the said new parish from the new parish of Saint James, Wardleworth, also sometime part of the parish of Rochdale aforesaid, at a point near the north-eastern end of Buckley Mill, in the centre of the bridge which carries over Buckley Brook the lane leading from Buckley Mill to Low Mill, and extending thence northin the county of Lancaster, and in the diocese of "Whereas at certain extremities of the said new parish of Saint John, Smallbridge, and of the new parish of Saint James, Wardleworth, also
