ORDERS for the Court's going into Mourning on Wednesday next, the 20th instant, for Her late Serene Highness The Duchess of Schleswig - Holstein - Sonderburg - Augustenburg, Second Cousin of Her Majesty The Queen, and Mother of His Royal Highness The Prince Christian of Schleswig-Holstein, Her Majesty's Son-in-Law; viz.:

The Ladies to wear black Silk, fringed or plain Linen, white Gloves, Necklaces and Ear-rings, black or white Shoes, Fans, and Tippets.

The Gentlemen to wear black full-trimmed, fringed or plain Linen, black Swords and Buckles.

The Court to change the Mourning on Saturday, the 23rd instant; viz.:

The Ladies to wear black Silk or Velvet, coloured Ribbons, Fans and Tippets, or plain white, or white and gold, or white and silver Stuffs, with black Ribbons.

The Gentlemen to wear black Coats, and black or plain white, or white and gold, or white and silver Stuff Waistcoats, full-trimmed, coloured Swords and Buckles.

And on Wednesday, the 27th instant, the Court to go out of Mourning.

REGULATIONS

TO BE OBSERVED AT THE QUEEN'S COURTS AT BUCKINGHAM PALACE.

By Her Majesty's Command.

The number of Ladies and Gentlemen attending

It is expected that Gentlemen will present themselves at Her Majesty's Court only when in attendance upon the Ladies of their families.

Those Gentlemen who have not been presented to The Queen are, under such circumstances, eligible for presentation to Her Majesty at these Courts.

The Queen has been graciously pleased, with regard to these Courts, to dispense with the regulation that the Lady or Gentleman must attend the Court at which they propose to make presentations to Her Majesty.

All those Ladies and Gentlemen who have received cards of admission to Buckingham Palace are requested to bring with them two large cards with their names clearly written thereon, one to be left with the Queen's Page in attendance and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty. In the case of presentation the name of the presenter must be inserted on the card.

The State apartments will be open for the reception of Company an hour before each Court.
