

with respect to their movement within such limits as may be imposed by such licence :

And whereas in the said licence for the holding of the above-mentioned market, it is provided that no cattle brought into the said market shall be taken alive beyond the limits of the municipal boundaries of the borough of Wolverhampton, and it is expedient that certain other regulations should be made in this behalf :

Now, therefore, the Lords of the Council do hereby order, that notwithstanding such provision in the said licence, cattle sold in the said market may, until the first day of August next, if the said market shall continue to be licensed until that day, or if not, until the revocation or other sooner determination of the licence, be moved to slaughter-houses situated within the parliamentary boundaries of the boroughs of Wolverhampton, Coventry, and Warwick, in the county of Warwick, of Dudley, in the county of Worcester, and of Wolverhampton and Walsall, in the county of Stafford, and in the following parishes, towns, and places, all in the said last-named county, that is to say: the parishes of Kingswinford and Sedgley, and the towns and places of Handsworth, Smethwick, Darlaston, Wednesbury, West Bromwich, Tipton, Rowley Regis, Great Bridge, and Harborne, and to the towns and places of Aston and Saltley, in the county of Warwick, and at all intermediate places in the respective counties of Stafford and Warwick, between any of the above-named boroughs, parishes, towns, and places, and the parliamentary boundary of the said borough of Wolverhampton, to be there slaughtered under such regulations as the Local Authorities of the several counties in which these places shall be situated respectively, shall, from time to time, make and issue in regard to the movement, and the places, times, and manner of the slaughtering of such cattle :

Provided also, that the cattle shall be moved from the said market to the boroughs of Birmingham, Coventry, and Warwick; and to Aston and Saltley by railway only :

Provided always, that nothing herein contained shall allow the cattle to be kept alive for more than four days after exposure in the said market.

And the said Lords do further order that, notwithstanding any provision in the said licence or in any previous Order to the contrary, swine may be sold at any market or other place within the said borough of Wolverhampton, whether for immediate slaughter or otherwise, and need not be slaughtered within the municipal boundaries of the said borough within four days after exposure for sale.

This Order shall be published by the Local Authority of the county of Stafford, and every regulation made by the Local Authorities respectively under it, shall also be published in some newspaper circulating in the borough of Wolverhampton, and by a notice affixed in some conspicuous place in the said market :

Every person who shall contravene this Order, or any regulation of the Local Authorities made under it, shall be guilty of an offence, and be subject to the like penalty as in the case of a contravention of any regulation in the said Order of the 24th day of March, 1866.
