LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF ACT BY BRIERLEY HILL, IN THE COUNTY OF STAFFORD.

WHEREAS the Local Government Act, 1858, was duly adopted by the ecclesiastical district or parish of Brierley Hill, in the county of Stafford, on the 22nd day of February, 1867, and notice of such adoption has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act. And whereas it has now been duly certified to me that a copy of such notice has been duly advertised, and that copies of such notice have also been affixed to the principal doors of each church and chapel in such ecclesiastical district or parish to which notices are usually affixed; and no appeal against the resolution for the adoption of the said Act has been presented within the period prescribed for appeal by the said Act.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give notice, that the Local Government Act, 1858, has been duly adopted within the said ecclesiastical district or parish of Brierley Hill, in the county of Stafford, and that, in accordance with the provisions thereof, the said Act will, from and after the expiration of two months from the date of the passing of the resolution of adoption, have the force of law within the ecclesiastical district or parish of Brierley Hill aforesaid.
