### REGULATIONS

TO BE OBSERVED AT THE QUEEN'S LEVEE TO BE HELD BY HIS ROYAL HIGHNESS THE PRINCE OF WALES, ON BEHALF OF HER MAJESTY, AT ST. JAMES'S PALACE.

*By Her Majesty's Command.*

The Noblemen and Gentlemen, who propose to attend Her Majesty's Levee, at St. James's Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

### PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented, must leave at the Lord Chamberlain's Office, St. James's Palace, *before twelve o'clock*, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending

that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at a Levee, except in accordance with the above regulations.

It is particularly requested, that in every case the names be *very distinctly written* upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.

WHEREAS by an Order of the Lords of Her Majesty's Privy Council, bearing date the 24th day of March, 1866, reciting certain provisions of the Act of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, which has been continued by divers Acts, and lastly by an Act of the last session of Parliament, until the first day of August next and the end of the then next session of Parliament, and the appearance and prevalence of a contagious or infectious disorder generally designated the "Cattle Plague" amongst cattle in England and Wales, and sundry other matters, the said Lords did, in exercise of the powers given by the said Act so continued as aforesaid, make divers rules and regulations in reference to cattle, and did, among other things, order that no cattle

should be moved on any highway between sunset and sunrise, except within the limits of the metropolis, inclusive of the city of London and the liberties thereof, or of any other city or town :

And whereas the said disorder still prevails in England, but it is expedient to make certain other regulations in respect of certain cattle moved to the metropolis :

Now, therefore, the Lords of the said Council do hereby order, that where cattle are brought by the Great Eastern Railway to the station termed the Tottenham Station and are there discharged to be driven or conveyed to the Metropolitan Cattle Market or lairs, such cattle may be moved on a highway after sunset on the Saturday and Sunday of each week, provided that they proceed forthwith from the railway station, along the road commonly called Seven Sisters'-road, with the licence required for the movement of cattle during the day time, and provided that the person moving such cattle be provided with a certificate, in writing under the hand of some officer appointed by the Great Eastern Railway Company, and approved by the said Lords of the Council, describing the cattle by proper marks, or otherwise, and certifying that such cattle have been brought to such station, and have been discharged therefrom, for the purpose of being moved to the Metropolitan Cattle Market or lairs, and setting forth correctly the day and hour of such discharge :

And the said Lords do hereby order the Local Authority of the county of Middlesex to publish this Order by causing the same to be advertised in some newspaper circulating in the county of Middlesex, and a copy thereof to be affixed in some conspicuous place at the Tottenham Station of the railway aforesaid ; and this Order shall be construed as the said Order of the 24th day of March, 1866, and every person who shall contravene it shall be subject to the like penalty as in the case of a contravention of any regulation under that Order.

**W**HEREAS by an Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, intituled "An Act to prevent until the first day of September, one thousand eight hundred and fifty, and to the end of the then session of Parliament, the spreading of contagious or infectious disorders among sheep, cattle, and other animals," and from time to time continued until the first day of August, one thousand eight hundred and sixty-seven, by divers subsequent Acts, and lastly by an Act passed in the last session of Parliament,

it is (amongst other things) enacted, that it shall be lawful for the Lords and others of Her Majesty's Privy Council, or any two or more of them, from time to time, to make such Orders and Regulations as to them may seem necessary for the purpose of prohibiting or regulating the removal to or from such parts or places as they may designate in such Order or Orders, of sheep, cattle, horses, swine, or other animals, or of hay, straw, fodder, or other articles, likely to propagate infection, and to make any other Orders or Regulations for the purpose of giving effect to the provisions of the said Act, and again to revoke, alter, or vary any such Orders or Regulations ; and that all provisions for any of the purposes aforesaid in any such Order or Orders contained shall have the like force and effect as if the same had been inserted in the said Act :

And whereas a contagious or infectious disorder, generally designated as the "Cattle Plague," has lately appeared, and still prevails, amongst cattle in some parts of England :

And whereas by an Order bearing date the 24th day of March, 1866, duly made by the Lords of the said Council, it was among other things ordered, that until the first day of June, one thousand eight hundred and sixty-six, all cattle brought by sea from any place out of the United Kingdom into any town or place in England shall be marked by clipping the hair off the end of the tail, and no such cattle shall be removed alive from such town or place, except by sea, which regulations have, by a subsequent Order, been continued in force until the Lords of the Council shall otherwise order :

And whereas there is a certain market held for the sale of cattle in the parish of Saint Mary, Islington, in the county of Middlesex, known as the Metropolitan Cattle Market, which market has been licensed by the Lords of the said Council for the sale of cattle intended for immediate slaughter so long as the above-mentioned Orders shall remain in force, or until the same licence shall be revoked, and it is advisable that regulations should be made for the removal of certain cattle to such market to be sold for immediate slaughter :

Now, therefore, the Lords of the said Council do hereby order that from and after the date of this Order cattle brought by sea from any place out of the United Kingdom to and landed in the port of Harwich, in the county of Essex, may be removed by railway to such market, for the purpose of being sold therein for immediate slaughter, any thing in the said recited Order to the contrary notwithstanding subject to the following regulations :

1. All such cattle shall be landed in such manner, at such times, and subject to such supervision and control as the Commissioners of Customs shall from time to time direct, and shall be conveyed without stopping, except for the purpose of feeding or being watered, from the place where they shall be landed to the said market.

2. They shall be brought from the pens and sheds at the said Port specially appropriated for cattle intended for immediate slaughter, and shall be moved by rail to the railway belonging to the Great Eastern Railway Company, and thence along such railway in trucks or carriages exclusively set apart and used for the purpose of conveying cattle brought from abroad, and coloured with a red stripe 2 feet wide all round, to designate them as so appropriated, and such trucks and

carriages shall, after they have been used for the purpose of conveying any cattle to the said market, be thoroughly cleansed and disinfected in such manner as may be necessary, or as the Lords of the Council may from time to time direct.

3. As soon as any truck or carriage shall have conveyed such cattle as aforesaid to the said market, and discharged them there, and have been so cleansed and disinfected, it shall be removed from the neighbourhood of the said market, and returned forthwith to the place from which it shall have brought the cattle.

4. If any truck or carriage is at any time used in contravention of any regulation herein contained, the company or person by whom it is used shall, every time that such truck or carriage is so used, be liable to a penalty not exceeding five pounds.

5. This Order shall be published by the Local Authority of the Borough of Harwich, by advertisement in some newspaper circulating in the said borough, and by affixing a copy thereof at some conspicuous place at the said port, and at the principal railway station adjoining thereto, and shall be construed in like manner as the said Order of the 24th day of March, 1866; and all the provisions therein contained relative to the offences for the contravention thereof, and the penalties for the same, and the powers of the officers employed under it, as others, shall apply to this Order, except so far as they may be inconsistent with anything herein contained.

Further, the Regulations of the Custom House which have reference to the baggage of travellers by railroads have been modified.

The Treasurer-General, Minister of Finance, has prescribed the arrangements necessary for the execution of the orders of His Holiness.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, through the Secretary of State for Foreign Affairs, from Her Majesty's Ambassador at Paris, an extract from the "Moniteur," respecting a law relative to the guarantee of inventions susceptible of being patented, and of patterns which are admitted to the Exhibition.

LAW.

Art. 1. Every Frenchman or foreigner, the author of a discovery or invention susceptible of being patented, according to the provisions of the

law of the 5th July, 1844, or of a design which ought to be deposited in conformity with the law of the 18th March, 1806, or those to whom they have assigned their rights can, if they have been admitted to the Universal Exhibition, obtain from the Imperial Exhibition Commission a certificate descriptive of the object deposited. This certificate ought to be demanded during the first month, at the latest, after the opening of the Exhibition.

Art. 2. This certificate assures to the person who obtains it the same rights that a patent or legal deposit of the design would confer upon him, dating from the day of admission by the French or foreign authority charged with this duty till the 1st April, 1868, even when this admission shall have been anterior to the promulgation of the present law, and without detriment to the patent which the exhibitor can take out or to the deposit which he can effect before the expiration of this term.

Art. 3. Demands for certificates ought to be accompanied by an exact description of the article to be guaranteed, and, provided there is space, by a plan or design of the said article.

These demands, as well as the decisions arrived at by the Imperial Commission, will be entered in a special register, which will be finally deposited with the Minister for Agriculture, Trade, and Public Works.

#### NOTICE TO MARINERS.

(No. 19).—BAY OF BENGAL.

*Fixed Light, Great Coco Group, Andaman Islands.*

NOTICE has been received, through the Secretary of State for India, that since the 15th day of February, 1867, a light, called the Cocos Light, has been exhibited from a lighthouse recently erected on Table Island, Great Coco Group, Andaman Islands.

The light is a *fixed* white-light, elevated 200 feet above the level of the sea, and in clear weather should be seen from a distance of 20 miles.

The illuminating apparatus is dioptric, or by lenses, of the first order.

The lighthouse is an iron building, 72 feet high, built on the highest part of Table Island, one of two islands, Table and Skipper, lying close together, and forming the most northern of the Coco Islands, in lat.  $14^{\circ} 8\frac{1}{2}'$  N., long.  $93^{\circ} 18'$  East of Greenwich.

*Directions.*—The Cocos Light, placed as it is at the southern limit of the Preparis South Channel, will, for vessels passing between the Gulf of Martaban and the Madras Coast, and between Calcutta and the Malacca Straits or China, form a good point of fresh departure in the S.W. monsoon, while the Alguada Reef revolving light, placed at the northern limit of the Preparis North Channel, is a good point of fresh departure in the N.E. monsoon. By shaping a course to make either of these lights, the dangers about Preparis Island are avoided.

All vessels using the Preparis Channels would, in the S.W. monsoon, endeavour to make the Cocos Light, and in the N.E. monsoon, the Alguada Light, except powerful steamers between Calcutta and the ports of Pegu, which would use the latter in both monsoons.

Table and Skipper Islands are steep to, with no dangers to seaward; there is a passage between them and the Great Coco Island, but it is not safe to attempt it without a pilot.
