THE Department of Trade and Customs at Melbourne has given notice, that the temporary fixed red and green light on Point Lonsdale was to be discontinued after the 25th day of February, 1867, and that a light of the same character, but

be exhibited from the lighthouse near Point Lonsdale Telegraph station.

From seaward the light will appear green between the bearings of about N. by W. and N.W. $\frac{1}{2}$ W.; and red between N.W. $\frac{1}{2}$ W. and W. by S.; in clear weather the light should be seen from a distance of 10 miles.

By referring to the chart it will be seen that the N.W. $\frac{1}{2}$ W. line passes near the Lonsdale and Lightning rocks, and navigators are therefore cautioned to be on their guard before the colours begin to change, as the blending of the red and green lights will indicate close vicinity to the line which passes from the lighthouse over these dangers.
