

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the Perpetual Curacy of Holy Trinity, Corris, in the county of Merioneth, and in the diocese of Bangor, and to his successors, incumbents of the same benefice, all those tithes or rent-charges in lieu of tithes, with their appurtenances, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithes or rent-charges in lieu of tithes, with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same benefice shall be entitled to receive from us, or on our account, the net amount of the rents, profits and proceeds of the said tithes or rent-charges in lieu of tithes, with their appurtenances, as from the first day of July, in the year one thousand eight hundred and sixty-six.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant to the incumbent of the perpetual curacy of Saint John, Bury, in the county of Lancaster, and in the diocese of Manchester, and to his successors, Incumbents of the same benefice, one yearly sum or stipend of fifty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and sixty-seven, and to be receivable half-yearly, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments, sufficient to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said benefice in substitution for such yearly sum or stipend, or for such part thereof, our liability

for the payment of such yearly sum, or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
