NOTE.—The above mentioned sum of £204 10s. 8d. comprises all the impropriate rent-charge in the parish of Ashill, with the exception of £16 charged upon the rectorial glebe.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Beaminster, with the chapelry of Holy Trinity annexed, in the county of Dorset, and in the diocese of Salisbury, and to his successors incumbents of the same benefice, all those two pieces or parcels of land and hereditaments, with their appurtenances, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said pieces or parcels of land and hereditaments, with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided always, that in consideration of the said grant and conveyance, the annual sums or stipends, amounting together to twenty-six pounds, payable by us to the Incumbent for the time being of the same benefice, under the provisions of certain Orders of Her Majesty in Council bearing date respectively the thirty-first day of July, in the year one thousand eight hundred and fifty-eight, and the eleventh day of October, in the year one thousand eight hundred and sixty-one, shall, as from the sixteenth day of March, in the year one thousand eight

hundred and sixty-seven, be reduced to an annual sum or stipend of eight pounds and three shillings; and provided also, that the Incumbent for the time being of the same benefice shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said pieces or parcels of land and hereditaments, with their appurtenances, as from the said sixteenth day of March, in the year one thousand eight hundred and sixty-seven.

In witness whereof, we have hereunto set our common seal, this fourth day of July, in the year one thousand eight hundred and sixty-seven.

All that piece or parcel of land, containing three roods and thirty-six perches, or thereabouts, situate within the parish of Beaminster, in the county of Dorset, having been parcel of a field there called Hogshill Mead, and numbered 311 upon the title commutation apportionment map of the said parish, and bounded on the north by the vicarage house and garden, on the west by land belonging to the representatives of Charles Legg, deceased, on the south by Short's-lane, and on the east by lands belonging to Ann Curtis.
