WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of two roods and thirty four perches of land, together with a messuage or dwelling-house erected thereon, which has been permanently secured to the perpetual curacy of Saint John the Evangelist, Bush End, in the county of Essex, and in the diocese of Rochester, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said perpetual curacy of Saint John the Evangelist, Bush End, and to his successors, to meet such benefaction, one yearly sum or stipend of nineteen pounds three shillings and four pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable half-yearly on the first day of
