

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the perpetual curacy of Saint Mary, Wavertree, in the county of Lancaster, and in the diocese of Chester, and to his successors, Incumbents of the same benefice, all those tithe commutation rent-charges, with their appurtenances, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithe commutation rent-charges, with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same benefice shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent-charges, with their appurtenances, as from the first day of January, in the year one thousand eight hundred and sixty-seven.
