ARTICLE I.- That so much of the said Act passed in the fourteenth year of the reign of Her Majesty, intituled "An Act to prevent the " holding of Vestry or other Meetings in Churches, " and for regulating the appointment of Vestry "Clerks," as relates to the appointment of a Vestry Clerk shall forthwith be applied to and be put in force within the said parish of Woodford.

ARTICLE II.-That the Churchwardens and Overseers of the Poor of the said parish shall, unless the Poor Law Board otherwise direct, pay to the officer for the time being appointed to the said office of vestry clerk for the said parish, under the authority of the Statutes in that behalf and this Order, for the performance of the duties of such office, a salary of fifty two pounds ten shillings per annum.

ARTICLE III. - That the salary of such vestry clerk shall, be payable up to the day on which he ceases to hold such office, and no longer, and shall be paid by quarterly payments at the several quarters ending at the usual Feast Days in the year, namely, Michaelmas Day, Christmas Day, Lady Day, and Midsummer Day, with a proportionate sum to be paid to his executors or administrators, in case he shall die while holding such office.
