to make inquiry into the laws relating to Juries, especially with reference to the qualifications, summoning, nominating, and enforcing the attendance of Jurors, with a view to the better, more regular, and more efficient conduct of Trials by Jury, and the attendance of Jurors at such Trials.

And for the better discovery of the truth in the premises We do, by these presents, give and grant to you, or any six or more of you, full power and authority to call before you, or any six or more of you, such and so many of the Officers and Clerks of Our said Courts, and all such other persons as you shall judge necessary, by whom you may be informed of the truth in the premises, and to enquire of the premises by all other lawful ways and means whatsoever.

And We do hereby give and grant unto you, or any six or more of you, full power and authority to cause all or any of the Officers and Clerks of any of Our said Courts to bring and produce before you, or any six or more of you, all rolls, records, orders, books, papers, or other writings belonging to any of Our said Courts, or to any of the Officers within the same.

And Our further will and pleasure is that you do within nine calendar months after the date of this Our Commission, or as soon as the same can conveniently be done (using all diligence), certify unto Us, in Our Court of Chancery, under the hands and seals of you, or any six or more of you, what you shall have done in the premises.

And We further will and command that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any six or more of you, shall and may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And for your assistance in the due execution of this Our Commission, We have made choice of Our trusty and well-beloved Thomas Joseph Bradshaw, Esquire, Barrister - at - Law, to be Secretary to this Our Commission, and to attend you, whose services and assistance We require you to use from time to time as occasion shall require.

Given at Our Court at St. James's, the eighteenth day of September, one thousand eight hundred and sixty-seven, in the thirty-first year of Our reign.
