LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF PARTS OF ACT BY THE IMPROVEMENT COMMISSIONERS OF ABERYSTWITH, IN THE COUNTY OF CARDIGAN.

WHEREAS the Commissioners acting in and for the town of Aberystwith, in the county of Cardigan, under and by virtue of their Improvement Act (5 and 6 William IV., cap. 46), did, on the 17th day of August, 1867, adopt various parts, sections, and provisions of the Local Government Act, 1858, within their district, as set forth in their notice to me (in writing) as one of Her Majesty's Principal Secretaries of State, and dated the 22nd day of October, 1867:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby give notice, that the sections and portions of the Local Government Act, 1858, that is to say, sections 32, 33, 34, 35, 38 (and the sections of the Public Health Act, 1848, therein referred to), also sections 41, 44 (and the enactments thereby incorporated), 45, 52, 57, 61, 62, 66, 75, and 78, have been duly adopted, and that in accordance with the Local Government Act, 1858, the said portions of the hereinbefore-recited Act will, from the date of the notice of the adoption thereof, have the force of law within the district of the aforesaid Aberystwith Improvement Commissioners.
