LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF PARTS OF ACT BY THE IMPROVEMENT COMMISSIONERS OF ABERYSTWITH, IN THE COUNTY OF CARDIGAN.

WHEREAS the Commissioners acting in and for the town of Aberystwith, in the county of Cardigan, under and by virtue of their Improvement Act (5 and 6 William IV., cap. 46), did, on the 3rd day of December, 1867, adopt a certain section of the Local Government Act, 1858, within their district (that is to say, section 77 of such Act), as set forth in their notice to me (in writing) as one of Her Majesty's Principal Secretaries of State, and dated the 12th day of December, 1867:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby give notice, that the said 77th section of the Local Government Act, 1858, has been duly adopted, and that in accordance with the Local Government Act, 1858, the said section of the hereinbefore-recited Act will, from the date of the notice of the adoption thereof, have the force of law within the district of the aforesaid Aberystwith Improvement Commissioners.
