of the rectory of the parish of Bilton aforesaid, and also the patron of the same rectory, and being under the common seal of us the said Ecclesiastical Commissioners for England (which deed is intended to be enrolled in your Majesty's High Court of Chancery at Westminster), the said Richard Orme Assheton did give, grant, and convey unto us the said Ecclesiastical Commissioners for England, and to our successors, in aid of the endowment of the district hereinafter recommended to be constituted, and of the maintenance of the minister thereof for the time being, certain pieces or parcels of land situate in the parish of Bilton aforesaid, and containing in the whole nine acres two roods and twenty-five perches, or thereabouts, and also certain tithe commutation rents-charge, amounting in the aggregate to the sum of eighty pounds nine shillings and one penny yearly, arising and issuing out of or from certain lands situate in the said parish of Bilton.

"And whereas the said pieces or parcels of land, and tithe commutation rents-charge, have been so given, granted, and conveyed as aforesaid, upon the understanding, that we should make, and pay out of the common fund created by the firstly herein-named Act, to the minister for the time being of the said district, when duly licensed, in accordance with the provisions of the herein secondly-named Act, a grant of fifty pounds per annum, and, upon the further understanding, that (such arrangement appearing to us to be expedient) the whole right of patronage of the said district, and of the nomination of the minister thereof, should be assigned in the manner hereinafter mentioned.

"And whereas we have agreed to make the said grant of fifty pounds per annum as aforesaid, by an instrument to be executed by us under our common seal, in accordance with the provisions of the Act of the twenty-ninth and thirtieth years of your Majesty, chapter one hundred and eleven.

"Now, therefore, with the consent of the Right Reverend Henry, Bishop of the said diocese of Worcester (in testimony whereof he has signed and sealed this scheme), we humbly recommend and propose, that all that part of the said parish of Bilton, which is described in the schedule hereunder written; all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication, in the London Gazette, of any Order of your Majesty in Council ratiying this scheme, become and be constituted a separate district for spiritual purposes, and that the same shall be named 'The District of New Bilton.'

"And we further recommend and propose, that the whole right of patronage of the said district so recommended to be constituted, and of the nomination of the minister thereof, shall, without any assurance in the law, other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid, be assigned to, and be absolutely vested in, and shall and may, from time to time, be exercised by the said Richard Orme Assheton, his heirs, and assigns, for ever.

"And we further recommend and propose, that the said pieces or parcels of land, and the said tithe commutation rents-charge, so given, granted, and conveyed to us and our successors as aforesaid. and all our estate and interest therein, shall, without any conveyance or assurance in the law, other than this scheme, and any duly gazetted same, become, and be transferred to, and become absolutely vested in, the minister of the district so recommended to be constituted, so soon as one shall be appointed and licensed, in accordance with the provisions of the herein secondly-named Act, and in his successors ministers of the same district.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.

The SCHEDULE to which the foregoing Scheme has reference.

"The District of New Bilton, being :-

"All that part of the parish of Bilton, in the county of Warwick, and in the diocose of Worcester, which is situate to the north of an imaginary line, commencing upon the boundary which divides the parish of Newbold-upon-Avon, in the said county and diocese, from the parish of Bilton aforesaid, at the point where Lawford Brook, otherwise called Sowbrook, is joined by a certain stream flowing from Mr. Line's pond, such point of junction being at a distance of eleven chains, or thereabouts, to the south of the bridge, which carries the line of the Rugby and Leamington Branch Railway over Lawford Brook aforesaid; and extending thence, south-eastward, for a distance of twenty-nine chains, or thereabouts, along the middle of the said Lawford Brook, to the centre of the bridge which carries Clay Pit-lane, over the same brook; and extending thence, northward, for a distance of fourteen chains, or thereabouts, along the middle of the said lane, to a point opposite to a boundary stone, it scribed 'N. B. D. 1867, No. 1,' and placed upon the eastern side of the same lane, at the south-western end of the line of fences which divides the closes numbered respectively. 71, 72, 76, 51, and 50, upon the tithe commutation map of the said parish of Bilton, and upon the map hereunto annexed, from the closes numbered respectively, 86 and 85, upon the said maps, and from a certain close unnumbered, being regarded as tithe free, and from the closes numbered respectively, 78 and 80, upon the same maps; and extending thence, north-eastward, to such boundary stone; and continuing mainly in the same direction along the said line of fences to a boundary stone inscribed 'N. B. D., 1867, No. 2,' and placed at the north eastern extremity of the same line of fences upon the boundary which divides the said parish of Bilton from the particular district of Saint Matthew, Rugby, in the county and diocese aforesaid."

And whereas a draft of the said scheme has, in accordance with the provisions of the hereinbefore secondly mentioned Act, been transmitted to the patron of the parish out of which it is intended that the district therein recommended to be constituted shall be taken, and the said patron is also incumbent of the same parish, and he has, as such patron, and also as such incumbent as aforesaid. signified his assent to such scheme.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law imme-Order of your Majesty in Council ratifying the diately from and after the time when this Order
