shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester.

HEREAS the Ecclesiastical Commissioners for England, have in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twelfth day of December, in the year one thousand eight hundred and sixty-seven, in the words following; that is

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint James, situate in the parish of Saint Mary and Saint Germain, Selby, in the county of York, and in the diocese of York.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint James, situate at Selby aforesaid.

"Now, therefore, with the consent of the Right Honourable and Most Reverend William, Arch bishop of York (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that portion of the said parish of Saint Mary and Saint Germain, Selby, which is described in the schedule hereunder written, all which portion, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint James, situate at Selby as aforesaid, and that the same should be named 'The District Chapelry of Saint James, Selby?'

"And, with the like consent of the said William, Archbishop of York (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, and churchings, should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend Francis Whaley Harper, the present incumbent of the perpetual curacy of the parish of Saint Mary and Saint Germain, Selby aforesaid, shall remain such incumbent, all the fees which may be received in respect of the performance of the said offices in such church as aforesaid, shall be paid over by the minister thereof to the said Francis Whaley Harper: And provided also, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

The District Chapelry of Saint James, Selby, being :-

"All that portion of the parish of Saint Mary and Saint Germain, Selby, in the county of York and in the diocese of York, which is comprised within and is bounded by an imaginary line commencing at the point near the western end of the Market-place where the street or road called or known as Gowthorpe joins New-lane; and extending thence, south-westward, for a distance of two chains, or thereabouts, along the middle of the said lane, to its junction with Market-lane; and extending thence, eastward, along the middle of the last named lane, to its junction with Jamesstreet; and extending thence, southward, for a distance of one chain, or thereabouts, along the middle of the last-named street, to its junction with the street called or known as Abbey-yard or Little Park-street; and extending thence, first eastward and then north-eastward, along the middle of the last-named street, to its junction with Park-street; and extending thence, southeastward, for a distance of twelve chains, or thereabouts, along the middle of the last-named street, to the centre of the line of the Leeds and Selby Railway, now called the North Eastern Railway; and extending thence, south-westward, for a distance of thirty-seven chains, or thereabouts, along the middle of the said line of railway, to the point where it strikes the eastern side of the Doncaster and Selby Trust-road, at or near to its junction with Brayton-lane; and extending thence, northward, for a distance of thirteen chains, or thereabouts, to and along the middle of the same lane, to a point opposite to the middle of the western end of the wall which forms the southern boundary of the gardens and premises belonging to the parsonage house of the said parish of Saint Mary and Saint Germain, Selby; and extending thence, eastward, to and along the middle of the said wall or fence to its eastern extremity on the western side of Parsonage-lane; and continuing thence, still eastward, to the middle of the last-named lane; and extending thence, north-westward, along the middle of the same lane to its junction with the street or road called or known as Gowthorpe aforesaid; and extending thence, north-eastward, for a distance of twenty-two chains, or thereabouts, along the middle of the last-named street or road to its junction with New-lane, where the said imaginary line commenced. Save and except from the abovedescribed portion of the said parish of Saint Mary and Saint Germain Selby, all that plot or parcel of ground containing by admeasurement two roods and three perches or thereabouts, which is situate on the eastern side of New-lane aforesaid, and upon which the buildings and premises, known as
