placed."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the' like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of York.

THEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirtyfour ; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the fifth day of December, in the year one thousand eight hundred and sixty-seven, in the words and figures following ; that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five ; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of the Holy Trinity, situate at Wallington, in the parish of Beddington, in the county of Surrey, and in the diocese of Winchester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of the Holy Trinity, situate at Wallington aforesaid.

"Now, therefore, with the consent of the Right Reverend Charles Richard, Bishop of the said diocese of Winchester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Beddington, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of the Holy Trinity, situate at Wallington, as aforesaid, and that the same should be named 'The District Chapelry of Wallington.

"And, with the like consent of the said Charles Richard, Bishop of the said diocese of Winchester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should

the Selby Abbey Church National Schools are be published, and that marriages, baptisms' and churchings, should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the minister of the same church for the time being : Provided always, that so long as the Reverend Alexander Henry Bridges, the present rector or incumbent of the Rectory of the said parish of Beddington, shall continue to be such rector or incumbent all the fees which may be received in respect of the performance of the said offices in such church as aforesaid, shall be paid by the minister thereof to the said Alexander Henry Bridges : and provided also, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

> "We, therefore, humbly pray that your Majesty. will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Wallington, being :-

"All that part of the parish of Beddington, in the county of Surrey and in the diocese of Winchester, which is comprised within, and is. coextensive with that portion of the hamlet of Wallington, which is situate to the south of an imaginary line commencing upon the eastern boundary of the said bamlet, at the western angle of the close numbered 167 upon the Tithe Commutation Map of the parish of Beddington and the hamlet of Wallington aforesaid, and upon the map hereunto annexed, in the middle of the southeastern extremity of the fence dividing the close numbered 392 upon the said maps from the close numbered 365 upon the same maps; and extending thence north-westward along the middle of the said fence to a boundary stone inscribed 'W. D. C., 1867, No. 1,' and placed at the north-western extremity of the same fence, on the eastern side of the road leading from Mitcham to Wallington; and extending thence first westward to a point in the middle of the said road, and then south-westward for a distance of six chains along the middle of the same road to a point opposite to a boundary stone inscribed 'W. D. C., 1867, No. 2,' and placed on the western side of the same road, in the middle of the south-eastern extremity of the fence dividing the close numbered 386 upon the said maps, from the closes numbered respectively 389 and 382 upon the same maps; and extending thence northwestward to such boundary stone and along the middle of the last-described fence, and along the middle of the fence dividing the close numbered 385 upon the said maps, from the closes numbered respectively 382 as aforesaid, and 384, upon the same maps, to the north-western extremity of the last-mentioned fence on the right bank of the River Wandle; and continuing thence still northwestward and in a straight line across the said river; and extending thence first northward and then eastward along the left bank of the same river for a distance of eleven chains to the boundary which divides the said parish of Beddington from the parish of Carshalton, in the county and diocese aforesaid.

"Save and except from the above-described portion of the said hamlet of Wallington, all that
