and into the prayer of such petition, by Arnold Taylor, Esq., the Inspector appointed by me for the purpose, and he has duly reported to me thereon:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby, under the authority conferred upon me by the said Acts, order and direct that, from and after the date of this present Order, such portions of the parishes of Epping, Theydon Garnon and Theydon Bois, as are hereinafter described, shall form and constitute the Epping Special Drainage District; that is to say, the boundary line of such district shall commence at the point A on the plan annexed to Mr. Arnold Taylor's report hereinbefore mentioned, at the toll-gate, near the Bell Inn, on the road leading from London to Epping, and passes thence in a northerly and easterly direction, embracing the whole of the properties numbered 49, 50, 51, 52, 54, and 56, on the said plan, to the point B on the west side of Bury-lane, thence, northerly, along and including such lane, and after passing Bury Farm, easterly and southerly, and including the road leading to Bury Farm from Lindsey-street, to the point C on the east side of such road, thence, easterly and southerly, embracing the whole of the properties numbered 415, 416, 418, 755, 750, 746, and 744, to the point D, thence, easterly, along the southern boundary fences of the properties numbered 420, 426, and 427, to the point E, thence, along the easterly boundary fence of such last numbered property, to the point E I, at Vintry Park Farm, thence, along the westerly fence of the property numbered 430 on the said plan, to the point F, on the south side of the road leading from the town of Epping to North Weald, and from thence, in a westerly direction, along and including such road, to the point G, thence, easterly, along and including the road leading to Chipping Ongar, to the point H on the north side of such road, thence, southerly, crossing such road passing along the easterly boundary fence of other property numbered 970 on the said plan to the point I, thence easterly, along the boundary line separating the parish of Epping, from the parish of Theydon Garnon, to the point K, thence southerly and westerly, along and including the road which leads to Coopersale-street, Coopersale House, and the Hamlet, at the Fiddler's Public House, to the point L, thence around, and embracing the properties numbered 333, 332, 331, and 395, on the said plan to the point M on the south side of a watercourse, thence westerly, along and including such water-course to the point N, thence northerly, crossing such watercourse and passing along the easterly boundary fence of the property numbered 471, on the said plan to the point O on the south side of the road leading to Ivy Chimnies, thence westerly and northerly, along and including such road to the point P, thence, along the northern boundary fences of the properties numbered 432, 434, 442, and 443, on the annexed plan to the point Q on the west side of the road near the Little Forest, leading up to the town of Epping, and from thence, northerly, along and including such road and crossing the High-road, between London and Epping, to the starting point at A so completing the boundary of the aforesaid Special Drainage District for Epping.

SCOTLAND-WEST COAST-RIVER CLYDE.

Fixed Light off Garvel Point.

THE Commissioners of Northern Lights have given notice, that from the 23rd day of December, 1867, a light has been exhibited from a lighthouse recently erected off Garvel Point (East Greenock), in the River Clyde.

The light is a fixed red light, elevated 25 feet above the level of the sea, and in clear weather should be seen from a distance of 7 miles.

The illuminating apparatus is dioptric or by

lenses, of the fourth order.

The light is placed near the South edge of the Channel, at the bend, off Garvel Point, and bears from the light on the Steamboat Quay in front of the Custom House at Greenock S.E. by E. ½ E., and from Garvel House N.N.E. ½ E., distant 280 yards.

NOTICE TO MARINERS.

(No. 2.)—RED SEA—WESTERN COAST.

Shoal reported near Gurb Miune Island.

INFORMATION has been given by the Master of the Steamship Great Victoria, that on two different voyages in the Red Sea he has seen a shoal, not hitherto marked in the Charts. lying about 3 miles E. by N. from Gurb Miune Island, and with that island in a line with Miune Island (2 miles to the westward).

On the second occasion of Mr. Enright sighting the shoal, the sea broke heavily over it, and a strong wind prevented close examination.

By the bearing and distance from Gurb Minne Island above given, the position of the shoal would be in lat. 18° 32′ N., long. 38° 53′ East of Greenwich.

It will be observed that this reported shoal is in close proximity to a group of low sandy islands and shoals bordering the western coast of the Red Sea, and a considerable distance from the fairway track up and down the sea. Mariners are cautioned accordingly.
