NOTICE OF ADOPTION OF ACT BY THE IMPROVE-MENT COMMISSIONERS OF BOURNEMOUTH, IN THE COUNTY OF SOUTHAMPTON.

WHEREAS the Local Government Act, 1858, was on the 3rd day of December, 1867, duly adopted by the Commissioners acting under and by virtue of the Bournemouth Improvement Act, 1856 (19 and 20 Vict), and notice of such adoption has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act; and whereas it has been duly certified to me that a copy of such notice has been duly advertised, and that copies have also been affixed to the principal doors of each church and chapel in such district of Bournemouth, to which notices are usually affixed, and the period fixed by the said Local Government Act for appeal has now expired, and no such appeal has been made: Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give notice, that the Local Government Act, 1858, has been adopted within the said district of the Bournemouth Improve-Commissioners, acting under and by virtue of their Improvement Act, 1856; and that although the said district is a place with a population of less than 3,000, by the last census, it has appeared to me, that by reason of special circumstances, it is expedient that the said district should be allowed to adopt the said Act. SEWAGE UTILIZATION ACT, 1867.— SANITARY ACT, 1866.

St. Helen's (Isle of Wight).—Order dividing PARTS OF PARISH INTO SPECIAL DRAINAGE DISTRICTS.

WHEREAS a Petition has been duly presented to me, as one of Her Majesty's Principal Secretaries of State, under the provisions of the Sewage Utilization Act, 1867, and the Sanitary Act, 1866, signed by ratepayers of parts of the parish of St. Helen's, in the Isle of Wight, not included in the district of the Ryde Local Board of Health, praying for the settlement of the boundaries of Special Drainage Districts for the purposes of the Acts aforesaid:

And whereas, in pursuance of such Acts, and of the said Petition, I have directed inquiry to be made into the circumstances of the case, and report has been made thereon by Arnold Taylor, Esq., the Inspector appointed by me for such purpose:

Now, therefore, I, having taken the said circumstances and report into consideration, do hereby, under the authority conferred on me by the aforesaid Acts, order and direct that from and after the date hereof, all that part of the parish of St. Helen's, in the Isle of Wight, which is not under the jurisdiction or within the district of the Ryde Local Board of Health, and as hereinafter described, shall be divided, for the purposes of such Acts, into four Special Drainage Districts, to be styled respectively the Special Drainage District of St. John's; the Special Drainage District of Spring Vale; the Special Drainage District of Sea View; and the Special Drainage District of St. Helen's; and that the boundaries of such districts be as are hereinafter described;

No. 1. That the boundaries of the St. John's Special Drainage District shall consist of all that portion of the parish of St. Helen's that is not under the jurisdiction of the Local Board of Health of Ryde, and that lies west of the Bridle-road, which commences on the sea shore at the northeast corner of the Apley estate, at its junction with the boundary line of the town of Ryde, under the Ryde Improvement Act, 1854, and also west of the High-road, leading to Brading, until such High-road reaches the boundary line which divides the parish of St. Helen's from the parish of Brading, at West Ridge Cross, such Special Drainage District being bounded on the north by the sea, and on the south by the parish.

No. 2. That the Spring Vale Special Drainage District consist of all that part of the parish of St. Helen's, which lies to the eastward of the easterly boundary line of the St. John's Special Special Drainage District, and westward of a line commencing on the sea shore at the Saltern Marsh Sluice, and passing thence, southerly, along and excluding the trench which runs on the east side of the properties numbered 284, 285, 286, 289, 297,
