Board of Trade, Whitehall, February 24, 1868.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, through the Secretary of State for Foreign Affairs, an extract from the "Journal de St. Pétersbourg," of the 13th instant, from Her Majesty's Chargé d'Affaires at that capital, which contains a Decree of the Russian Government, dated 30th January, prohibiting the importation and manufacture of articles dyed or printed in arsenical colours.

The following are the Articles of the Decree :-

- 1. The importation, sale and manufacture in Russia of paper hangings wholly covered with arsenical colours, dull or brilliant, is altogether prohibited.
- 2. Light stuffs such as book-muslins, tarletans, muslins, and others of the same description wholly dyed with arsenical colours are prohibited altogether from being imported, sold or manufactured in Russia.
- 3. The only exception to the above rules shall be in the case of paper hangings and stuffs which have only designs, flowers, leaves, flies, lines, &c., &c., executed in arsenical colours upon a ground of other colours not arsenical.
