bounded by an imaginary line commencing upon the boundary which divides the said parish from the said new parish at the point where the street or road called or known as Silksworth-row joins Hylton-road; and extending thence westward for a distance of one mile or thereabouts along the middle of the last named road (thereby passing to the north of the Millfield Station of the Painshaw branch line of the North-Eastern Railway, and following in the latter part the boundary which divides the parish of Bishopwearmouth from the new parish of Saint Andrew, Deptford as aforesaid) to a point opposite to the middle of the northern end of the wall or fence forming the eastern boundary of the Bishopwearmouth Cemetery; and extending thence south-eastward to and along the middle of the said wall or fence to its south-eastern extremity; and continuing thence still south-eastward and in a straight line to a point in the middle of the Chester-road; and extending thence north-eastward for a distance of sixty-one chains or thereabouts along the middle of the same road to the point near the bridge over the Painshaw branch line of the North-Eastern Railway aforesaid, where the said Chester-road is joined by the cross road leading into the Durhamroad; and extending thence south-westward along the middle of the said cross road to its junction with the Durham-road aforesaid; and extending thence north-eastward along the middle of the last-named road (that is, following the road commonly known as the Old Durham-road) to its junction with Hind-street; and extending thence northward along the middle of the said street to its junction with the street or road called or known as Silksworth-row aforesaid; and extending thence north-westward along the middle of the lastmentioned street or road to the first described point at the junction of Silksworth-row with Hylton-road as aforesaid, upon the boundary which divides the parish of Bishopwearmouth from the new parish of Saint Andrew, Deptiord as aforesaid, where the said imaginary line commenced.

The Third SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Matthew, Silksworth, being:-

"All that part of the parish of Bishopwearmouth, in the county of Durham, and in the diocese of Durham, which is comprised within and is coextensive with that portion of the township of Silksworth, wherein the present incumbent of such parish now possesses the exclusive cure of souls. And also all that part of the new parish or South Hylton, in the same county and diocese, And also all that part of the new parish of which consists of that portion of the township of Silksworth aforesaid, which is bounded on the west by the parish of Painshaw, in the said county and diocese, on the south by the above described portion of the parish of Bishopwearmouth, on the east by the township of Bishopwearmouth, and on the north by an imaginary line extending along the middle of the Chester-road. And also all that part of the new parish of Saint Paul, Ryhope, in the county and diocese aforesaid, which is comprised within and is co-extensive with the limits of the township of Tunstall.

The Fourth SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Luke, Pallion, being :-

"All that part of the new parish of Saint Andrew, Deptford, in the county of Durham, and

in the diocese of Durham, which is bounded on the north by the parish of Southwick, in the said county and diocese, on the west by the new parish of South Hylton, in the same county and diocese, and on all other sides, that is to say, on the south and on the east, by an imaginary line commencing at the point where the boundary dividing the said new parish of Saint Andrew, Deptford, from the said new parish of South Hylton meets the boundary which divides the said new parish of Saint Andrew, Deptford, from the parish of Bishopwearmouth, in the county and diocese aforesaid, at a point in the middle of Hylton-road near to the north-western corner of the Bishopwearmouth Cemetery: and extending thence north-eastward for a distance of fifty-seven chains, or thereabouts, along the middle of Hylton-road aforesaid (following thereby in part the last-described boundary) to the junction of the said road with Cromwell-street; and extending thence northward for a distance of thirteen chains, or thereabouts, along the middle of the said street and along the middle of Diamond Hall-lane to the bend in the said lane where it abuts upon the southern bank of the Painshaw branch line of the North-Eastern Railway; and continuing thence northward and in a straight line to a point in the middle of the said line of railway; and extending thence north-westward for a distance of six chains, or thereabouts, along the middle of the same line of railway to a point under the centre of the bridge which carries the same line of railway over Diamond Hall-lane aforesaid; and extending thence north-eastward to and along the middle of the same lane to its junction at or near Diamond Hall with the road called or known as the Coachroad; and extending thence in a direction generally northward along the middle of the last-named road to its junction with the road called or known as Copperas House Bank; and extending thence westward along the middle of the last-named road to its junction with a certain footpath leading to the river bank; and extending thence northward along the middle of the said footpath to its northern end upon the southern bank of the River Wear; and continuing thence still in the same direction and in a straight line to the boundary in the middle of the same river which divides the said new parish of Saint Andrew, Deptford, from the parish of Southwick aforesaid."

And whereas a draft of the said scheme has, in accordance with the provisions of the hereinbefore secondly mentioned Act, been transmitted to the patrons and to the Incumbents of the parish and new parishes (out of which it is intended that the several districts therein recommended to be constituted shall be taken), and the said patrons and Incumbents have severally signified their assent to such scheme.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be for the with registered by the Registrar of the said diocese of Durham.
