for such purpose, and he has reported to me thereon.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, having taken the said petition and report into consideration, do hereby, in pursuance of the powers vested in me by the Local Government Act, 1858, make order as follows :—

1. That from and after the date of this present order, the boundaries hereinafter set forth and described and delineated on the plan referred to in and accompanying the Inspector's report, bearing date the 24th day of March, 1868, form and constitute the boundaries of the district to be called the Newquay District, for the purposes of the Local Government Act, 1858, and that the parts included in such boundaries so described and delineated shall, for the purposes of such Act, be deemed to be a place having a known and defined boundary, and may adopt the said Act accordingly.

The aforesaid boundaries commence at the point A, on the aforesaid plan, on Newquay beach, at low-water mark of ordinary spring tides ; thence across the said beach in a southerly direction to B, on the north side of the road leading from Newquay to St. Columb ; thence crossing the said road and along the east and south sides of fields numbered 452 to C, at Tolcarne-lane; thence southerly along the east side of the said lane, and including it, to D; thence along the south side of field numbered 449, to the Newquay Railway ; thence crossing the said railway and along the south side of field numbered 4496 to E; theuce along the east and south sides of field numbered 449a to F, on the road leading to Trenance; thence along the east side of the said road, and including it, to G; thence crossing the said road and along the south side of fields numbered 107 and 108 to H; thence southerly along the east side of field numbered 85 to I, on the boundary between the parishes of St. Columb Minor and Crantock ; thence westerly along the said parish boundary to K, on the south side of L'Henverlane; thence crossing the said lane and westerly along its north side to L; thence northerly along the east side of Sandy Close lane to M ; thence crossing Sandy Close lane and along the west side of field numbered 18 to N; thence westerly along the boundary between the parishes of St. Columb Minor and Crantock to O; thence across Fistral Beach to P, at the low-water mark of ordinary spring tides; thence northerly and easterly along the line of low-water mark and round Towan Head to the starting point at A, thus completing the boundaries of the aforesaid district of Newquay.

2. That Henry Francis Whitefield, Esq., of St. Columb aforesaid, Solicitor, be Summoning Officer, and take forthwith all such steps as may be necessary under the hereinbefore recited Act, for convening a meeting of the ratepayers of the said district of Newquay, to decide as to the adoption of the Local Government Act, 1858, within the boundaries of such district as fixed and settled by this present Order.

## Gun Barrel Proof.

(Additional Proof Houses in and near London; Further Alteration in Constitution of Birmingham Guardians; Further Amendment of Act.)

N OTICE is hereby given, that the promoters of two Bills now pending before the Honourable the House of Commons, one called "Gun Barrel Proof Bill," and the other called "Birmingham Proof House (No. 1) Bill," intend to propose the following (amongst other) alterations in the Gun Barrel Proof Bill, or in any Bill into which the said two Bills may, with the sanction of the House, be consolidated, viz. :--

- (A.) To empower the Master, Wardens, and Society-of the Mystery of Gun Makers of the city of London, to provide, maintain, and use Branch Proof Houses in cr within ten miles of the city of London, with all proper works and conveniences, and to apply to such Branch Proof Houses all or some of the provisions of the said Bills.
- (B.) To exclude Justices of the Peace residing in or within seven miles of the borough of Birmingham, and not being Justices for the said borough from being ex-officio Guardians of the Birmingham Proof House.
- (C.) To amend "The Gun Barrel Proof Act, 1855," in these and other particulars, and as regards both the said Master, Wardens, and Society, and the said Guardians.
