LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF PARTS OF THE PUBLIC HEALTH ACT, 1848, BY THE TRUSTEES FOR WATCHING, &C., THE TOWN OF GOSPORT, IN THE COUNTY OF SOUTHAMPTON.

WHEREAS the Trustees, acting under and by virtue of an Act of Parliament passed in the third year of the reign of His Majesty King George the Third (3 Geo. 3rd, c. 56), entitled "An Act for the better paving of the streets, and for preventing nuisances and other annoyances in the town of Gosport, in the county of Southampton," and also under another Act of Parliament passed in the fifty-fourth year of the reign of His said Majesty (54 Geo. 3rd, c. 20), entitled "An Act for watching, lighting, and cleansing the town of Gosport, in the county of Southampton, and for amending and rendering more effectual an Act passed in the third year of His present Majesty for better paving the streets and preventing nuisances and annoyances in the said town," have adopted various parts, sections, and provisions of the Local Government Act, 1858, within their district; and whereas they have, on the 24th day of March, 1868, adopted a section of the Public Health Act, 1848, not originally adopted by them, viz., section 74 of the aforesaid Public Health Act, for providing places of public recreation.

And whereas notice of such adoption of the said portion of the Act has been duly given in writing, to me, as one of Her Majesty's Principal Secretaries of State.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, as aforesaid, do hereby give notice, that the hereinbefore described section of the said recited Act (that is to say, section 74 of the Public Health Act, 1848) has been duly adopted, and that in accordance with the Local Government Act, 1858, the said portion of the hereinbefore recited Public Health Act
