

December, in the year one thousand eight hundred and sixty-seven, and to be receivable half-yearly on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said benefice in substitution for such yearly sum or stipend, or for such part thereof,

our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

In witness whereof, we have hereunto set our common seal, this second day of April, in the year one thousand eight hundred and sixty-eight.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the perpetual curacy of Saint James, Hayton, in the county of Cumberland, and in the diocese of Carlisle, and to his successors, Incumbents of the same benefice, all those tithe commutation rent charges, with their appurtenances, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithe commutation rent charges, with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided, always, that the Incumbent for the time being of the same benefice shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent charges, with their appurtenances, as from the sixth day of March, in the year one thousand eight hundred and sixty-eight.
