WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the rectory of Gateshead Fell, in the county of Durham, and in the diocese of Durham, one yearly sum or stipend of one hundred and twenty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from

the first day of November, in the year one thousand eight hundred and sixty-seven, and to be receivable half-yearly on the first day of May, and on the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said rectory of Gateshead Fell, shall be paid only upon the production to us, on or after the first day of May and the first day of November in each and every year, of a certificate under the hand of the Bishop of the said diocese of Durham, that an Assistant Curate, duly licensed by such Bishop, has been employed within the parish of Gateshead Fell aforesaid, during the half year then ended, and is in receipt of a salary after a rate of not less than one hundred and twenty pounds per annum: Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said rectory of Gateshead Fell.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the perpetual curacy of Rockcliff, in the county of Cumberland, and in the diocese of Carlisle, and to his successors, Incumbents of the same benefice, all those tithe commutation rent charges, with their appurtenances, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithe commutation rent charges, with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided, always, that the Incumbent for the time being of the same benefice shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent charges, with their appurtenances, as from the first day of May, in the year one thousand eight hundred and sixty-seven.
