also of offering our cordial congratulations that a life, so dear to your Majesty, and so precious to the country at large, especially to the people of Scotland, has been mercifully saved from the attempt of the assassin.

We humbly but heartily tender to your Majesty, the assurance of our deep sympathy with the anxiety and distress which the deplorable event has occasioned to your Majesty, and to the Royal

family.

We render praise and thanks to Almighty God for having so remarkably interposed for the preservation of His Royal Highness from the imminent peril to which he was exposed; and we earnestly pray that his recovery may soon be perfected, and that he may be long spared to be a comfort to your Majesty, and, by a noble, useful, and Christian life, to strengthen more and more the ties which unite the Royal family to an attached and loyal pe ple.

We gladly avail ourselves of this renewed occasion of conveying to your Majesty an expression of our warm attachment to your Majesty's Person and Government, and of our deep interest in everything that concerns the safety and happiness

of your illustrious Family.
