

already stored therein, for the due observance of the law, and that thence they may be conveyed to the place of embarkation, after the duties have been determined, in the presence of the respective officers in charge.

ART. 5. Goods that are sent into the Interior shall carry a free pass from the Comptroller of the Customs, which the Governor, or failing him, the Receiving Officer of the place whither they go for sale, shall take, and should the articles not be in conformity with the pass, the excess shall be confiscated, and its value be disposed of according to Article 9.

ART. 6. On the re-shipment of merchandize for foreign parts, no duty shall be levied—requisition having to be made in such case on stamped paper, No. 4.

ART. 7. Indigo, coffee, cotton, and sugar, exported by the port of Amapala, shall be free from all export duty, and a premium of 4 per cent. shall be allowed on the first two articles, the amount being credited in import duties on foreign merchandize, indigo being valued at 75 cents per lb. and coffee at 10 cents. This concession shall be extended to the ports of Omoa and Truxillo, and shall last for four years.

ART. 8. The Supreme Congress shall publish a regulation of taxes to be levied, with the object of carrying out certain local improvements in the said port of Amapala.
