The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninetyseven; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the thirtieth day of April, in the year one thousand eight hundred and sixty-eight, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Chad, situate at Far Headingley, in the parochial chapelry of Headingley, within the original limits of the parish of Leeds, in the county of York, and in the diocese of Ripon.

"Whereas at certain extremities of the said parochial chapelry of Headingley, and of the new parish of Meanwood, in the county and diocese aforesaid, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such cures respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said parochial chapelry of Headingley, and of the said new parish of Meanwood, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Chad, situate at Far Headingley as aforesaid.

"Now, therefore, with the consent of the Right Reverend Robert, Bishop of the said diocese of Ripon, with the consent of the Reverend James Atlay, Doctor in Divinity, the vicar or incumbent of the vicarage of the said parish of Saint Peter, Leeds, and as such the patron of the perpetual curacy of the said parochial chapelry of Headingley, and with the consent of Sir Thomas Beckett, of Somerby Park, in the county of Lincoln, Baronet, the patron of the vicarage of the said new parish of Meanwood (in testimony whereof they have respectively signed and sealed this representation), and with the consents of the patrons of the church and vicarage of Saint Peter, Leeds (in testimony whereof they have hereunto affixed their common seal), we, the said Ecclesiastical Commissioners, humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parochial chapelry of Headingley, and of the said new parish of Meanwood, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Chad, situate at Far Headingley as aforesaid, and that the same should be named 'The Consolidated Chapelry of

> "We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Chad, Far Headingley, being :-

"All those contiguous portions of the parochial chapelry of Headingley within the original limits of the parish of Leeds, in the county of York, and in the diocese of Ripon, and of the new parish of Meanwood, in the said county and diocese, which are bounded on the west, partly by the district parish of Saint Stephen, Kirkstall, and partly by the new parish of Woodside, both in the county and diocese aforesaid; on the north, by the parish of Addle (otherwise called Adel), in the same county and diocese; and on all other sides, that is to say, on the east and on the south, by an imaginary line, commencing upon the boundary which divides the last-named parish from the new parish of Meanwood aforesaid, at the point near Smithy Mills where Meanwood Beck is joined by the stream which flows from Weetwood Farm, and is known as Weetwood Lane Beck; and extending thence southward along the middle of the said Meanwood Beck to the boundary at the Hollin Lane Bridge, which divides the said new parish of Meanwood from the parochial chapelry of Headingley aforesaid; and extending thence south-eastward along the lastdescribed boundary, thereby continuing along the course of Meanwood Beck aforesaid to the centre of Monk Bridge; and extending thence, first westward, then south-westward, and then northwestward along the middle of the Monk Bridge Road, otherwise called Headingley Moor, to the junction of such road with Shaw Lane; and extending thence south-westward along the middle of the said lane to its junction with the Leeds and Otley Trust Road; and extending thence northwestward for a distance of eight chains, or thereabouts, along the middle of the said Trust Road to a point opposite to the end of the fence which forms the south-eastern boundary of the park and plantations attached to Kirkstall Grange; and extending thence, first westward, then southward, and then south-westward along the middle of the said fence to a point at the south-eastern angle of Batcliffe Wood, upon the boundary which divides the said parochial chapelry of Headingley from the district parish of Saint Stephen, Kirkstall aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty by and with the advice of Her said Council, is pleased hereby to ratify the said representation and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the Saint Chad, Far Headingley,' and that the right I London Gazette, pursuant to the said Acts; and
