The Queen has been pleased to direct letters patent to be passed under the Great Seal granting the dignity of a Viscount of the United Kingdom of Great Britain and Ireland unto Alexander Nelson, Baron Bridport, in that part of the said United Kingdom called Ireland, Major-General in Her Majesty's Army, and the heirs male of his body lawfully begotten, by the name, style, and title of Viscount Bridport, of Cricket Saint Thomas, in the county of Somerset, and of Bronté, in the Kingdom of Italy.

The Queen has been pleased to grant unto Thomas Jodrell Phillips, of Yeardsley, in the county palatine of Chester, Esquire, son of Shakespear Phillips, late of Manchester, in the county

palatine of Lancaster, by Harriet, his wife, daughter of John Jodrell (formerly John Bower), late of Henbury, in the said county of Chester, and sister of Francis Jodrell, late of Henbury and Yeardsley aforesaid, Esquires, all deceased, Her Royal licence and authority that he and his issue may, in compliance with an injunction contained in the last will and testament of his cousin, John William Jodrell (the eldest son of the said Francis Jodrell), late of Yeardsley aforesaid, Esquire, deceased take and henceforth use the surname of Jodrell, in addition to and after that of Phillips, and that he and they may bear the arms of Jodrell quarterly with those of Phillips; such arms being first duly exemplified according to the laws of arms, and registered in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect :

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, an extract from the “*Moniteur*,” publishing two Imperial Decrees, bearing date 6th June, 1868 :—

By the first a duty of 20 centimes per ton burthen is established, from the 1st January, 1869, on all ships, French or foreign, entering the port of Bordeaux laden, and coming from a long voyage or from a foreign country.

By the second a duty of 10 centimes per ton burthen is established, at the port of Dunkerque, from the 1st July, 1868, upon all vessels, French or foreign, with the exception of tugs, pilot-boats, and boats engaged in coast fishing.

These dues are to be levied solely for the purpose of covering the difference between the rate of interest paid by the State, for the loans contracted with the two towns of Bordeaux and Dunkerque respectively, and the rate paid by those two towns to the subscribers to the loans; and will consequently cease immediately upon the entire reimbursement of the sum which forms the difference.
