## LOCAL GOVERNMENT ACT, 1858.

ORDER SETTLING THE BOUNDARIES OF A STAYLEY DISTRICT, IN THE COUNTY OF CHESTER, FOR THE PURPOSES OF THE LOCAL GOVERNMENT ACT, 1858.

WHEREAS a Petition has been duly presented to me, as one of Her Majesty's Principal Secretaries of State, from ratepayers resident within certain portions of the township of Stayley, in the county of Chester (which portions are not included within the boundaries of the borough of Stalybridge, in the counties of Lancaster and Chester, nor in the district of the Local Board for Mossley, under [the powers and provisions of the Local Government Act, 1858), as set forth in such petition, praying me to settle and fix the boundaries of a district to be styled the "Stayley District," for the purposes of the Local Government Act, 1858.

And whereas the said petition was duly signed, as required by the said Act, and set forth, likewise, the proposed boundaries of a district sought to be formed under its provisions; and inquiry has now been duly made by Robert Morgan, Esquire, the Inspector appointed by me for such purpose, and he has reported to me thereon.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, having taken the said petition and report into consideration, do hereby, in pursuance of the powers vested in me by the Local Government Act, 1858, make order as follows :--

1. That from and after the date of this present order, the boundaries hereinafter set forth and described and referred to in the Inspector's report, bearing date the 21st day of July, 1868, shall form and constitute the boundaries of the district to be called the Stayley District, for the purposes of the Local Government Act, 1858, and that the parts included in such boundaries

so described, shall, for the purposes of such Act, be deemed to be a place having a known and defined boundary, and may adopt the said Act accordingly. The boundaries aforesaid to comprise all those portions of the township of Stayley which are not included within the boundaries of the borough of Stalybridge, nor within those of the district of the Mossley Local Board.

2. That Henry Braddock Bagshaw, Esq., of Stalybridge, be Summoning Officer, and take forthwith all such steps as may be necessary under the hereinbefore recited Act, for convening a meeting of the ratepayers of the said district of Stayley, to decide as to the adoption of the Local Government Act, 1858, within the boundaries of such district as settled and fixed by this present Order.

TO all to whom these presents shall come, we, the Ecclesiastical Commissioners for England, send greeting: Whereas it has been made to appear to us that certain tithes, or rent charges in lieu thereof, arising within the particular district of the Holy Trinity, Capenhurst, in the county of Chester, and in the diocese of Chester, belong to the Incumbent of the church of such particular district : Now, we, the said Ecclesiastical Commissioners for England, acting in pursuance of "The District Church Tithes Act, 1865," do hereby declare that from and after the time of the publication of these presents in the London Gazette, pursuant to the provisions of the same Act, the said church of the particular district of the Holy Trinity, Capenhurst aforesaid, shall be and be deemed to be a rectory.

In witness whereof, we, the Ecclesiastical Commissioners for England, have hereunto affixed our common seal, this ninth day of July, in the year one thousand eight hundred and sixty-eight.

WE, the Ecclesiastical Commissioners for England, having received a benefaction of seven hundred and fifty pounds sterling, in favour of the perpetual curacy of Saint James, Edgbaston, in the county of Warwick, and in the diocese of Worcester, in consideration whereof we have agreed to pay to the Incumbent of the same perpetual curacy, and to his successors, a yearly sum of twenty-five pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said perpetual curacy of Saint James, Edgbaston, and to his successors, to meet such benefaction, one other yearly sum or stipend of twenty-five pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable half-yearly, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the yearly sum or stipend so payable out of our common fund as lastly herein mentioned, or any part thereof, shall be annexed by us to the said perpetual curacy, in substitution for such yearly sum or stipend, or for
