LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF PARTS OF ACTS BY THE BOROUGH OF ROCHDALE, IN THE COUNTY OF LANCASTER.

WHEREAS the borough of Rochdale, in the county of Lancaster, did, on the 3rd day of September, 1868, adopt various parts, sections, and provisions of the Local Government Act, 1858, within the district comprised within the boundaries set forth by the Rochdale Improvement Act, 1853, that is to say, sections 77 and 78 of the first hereinbefore-named Act, and also section 19 of the Local Government Act (1858) Amendment Act, 1861, and all or any of the provisions of the said Local Government Acts, or either of them, or of any Act or Acts incorporated therewith, relating to the borrowing of monies necessary to carry out the said sections, or any of them :

And whereas notice of such adoption of the said portions of those Acts has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State :

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby give notice, that the hereinbefore described sections and portions of the said recited Acts have been duly adopted within the aforesaid district ; and that in accordance with the Local Government Act, 1858, the said portions of the herein-
