PEMBROKE DOCK .- Forthwith wholly in the Paris: Church; and that interment in the burial ground of St. John's, Pembroke Dock, be discontinued after the thirtieth of June, one thousand eight hundred and sixty nine, except in now existing vaults and walled graves, in which each coffin shall be cmbedded in charcoal and separately enclosed by stonework or brickwork properly cemented; and except in earthen graves which can be opened to the depth of five feet without exposing coffins or disturbing remains; such graves to be used only for the burial of the widowers, widows, parents, or unmarried children of those previously buried in the burial ground.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council on the second day of November next:

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation, one month before the said second day of November.
