NOTICE is hereby given, that a stone beacon, 4 feet above high water, stands on the eastern part of the outer and northernmost of St. Patrick rocks, in Killala bay, on the N.W. coast of Ireland, with the extreme of Kilcummin head N. 5 W., and the ruins of Castlenageeha W. $\frac{1}{8}$ N.

Also that a perch, consisting of an iron staff surmounted by a cage 30 feet above high water, stands on the eastern part of the inner or southernmost of St. Patrick rocks, with the stone beacon on the outer rock N. $\frac{3}{4}$ W., seven-tenths of a mile ; and the Round tower at Killala S.W. by W. 🛔 W.
