lished and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend Edward Wilson, the present vicar or incumbent of the vicarage of the said new parish of Saint Mary, Hunslet, shall continue to be such vicar or incumbent, all the fees which may be received in respect of such publication, solemnization, or performance at the said church of Saint Peter, situate at Hunslet Moor as aforesaid, shall be paid by the minister thereof to the said Edward Wilson; and provided also, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order with respect thereto as to your Majesty, in your

Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Peter, Hunslet Moor; being:—

"All that part of the new parish of Saint Mary, Hunslet, within the original limits of the parish of Leeds, in the county of York and in the diocese of Ripon, which is bounded on the west by the chapelry of Holbeck, also within the original limits of the said parish of Leeds, upon the north partly by the new parish of Brewery Field, and partly by the new parish of Pottery Field, both within the original limits of the parish of Leeds aforesaid, and upon the remaining sides, that is to say, upon the east, south, and south-west, by an imaginary line commencing upon the boundary which divides the said new parish of Saint Mary, Hunslet, from the said new parish of Pottery Field, at the point where Jack-lane is intersected by the Middleton Colliery Company's tramway; and extending thence, southward, for a distance of half-a-mile or thereabouts, along the middle of the said tramway, to a point opposite to the northeastern end of the fence which forms the southeastern boundary of the detached portion of the township of Holbeck which is included within the said new parish of Saint Mary, Hunslet; and extending thence, south-westward, for a distance of fourteen chains or thereabouts, along the lastdescribed fence and township boundary, to a point near Child's Farm where the said boundary joins the south-western boundary of the same detached portion of the township of Holbeck aforesaid, on the northern side of the footpath leading from Hunslet Carr towards Green-terrace; and extending thence, north-westward, for a distance of one chain and a-half, or thereabouts, along the last-mentioned township boundary, following thereby the northeastern side of the said footpath to its junction with the footpath leading to the New Inn; and extending thence, south-westward, along the middle of the last described footpath, to the point on the southern side of the New Inn aforesaid, where the said footpath joins the turnpike road leading from Leeds to Dewsbury, at or near to the milestone indicating one mile from Leeds, at which same point the footpath leading direct from Lady Pitlane also falls in; and extending thence, northwest-ward, across the said turnpike road, to and along the middle of the last described footpath (leaving Green Farm on the left), to the junction of the same footpath with Lady Pit-lane aforesaid; and continuing thence, still north-westward, along the middle of the said lane, to the point on Holbeck Moor, where the same lane is intersected by the boundary which divides the said new parish of Saint Mary, Hunslet, from the chapelry of Holbeck aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twelfth day of November, in the year one thousand eight hundred and sixty-eight, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nine-teenth and twentieth years of your Majesty, chapter fifty-five, have prepared and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church situate within the limits of the township and chapelry of Denton, in the parish of Otley, in the county of York, and in the diocese of Ripon.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church situate within the limits of the township

and chapelry of Denton aforesaid.

"Now, therefore, with the consent of the Right Reverend Robert, Bishop of the said diocese of Ripon (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would in our opinion be expedient that all that part of the said parish of Otley which is comprised within, and is co-extensive with, the limits of the township and chapelry of Denton sforesaid, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry
