**IN THE MATTER OF THE FACTORY ACTS  
EXTENSION ACT, 1867.**

WHEREAS due proof has been made to the satisfaction of me, the undersigned, Gathorne Hardy, one of Her Majesty's Principal Secretaries of State, that the customs of the Trades carried on in the Factories specified in the Schedule hereto, require that the children, young persons, and women working in such Factories should be employed between the hours hereinafter mentioned: Now I, the said Gathorne Hardy, in pursuance of the powers vested in me by the twelfth Article of the Schedule annexed to the Factory Acts Extension Act, 1867, do by this, my Order, give permission to the occupiers of the said Factories to employ the children, young persons, and women working in such Factories between the hours of seven o'clock in the morning and seven o'clock in the evening, or between eight o'clock in the morning and eight o'clock in the evening, instead of between the hours of six o'clock in the morning and six o'clock in the evening, subject to the conditions in the said Act contained.

**IN THE MATTER OF THE FACTORY ACTS  
EXTENSION ACT, 1867.**

WHEREAS Messrs. W. and R. Balston, the occupiers of a Paper Mill at Maidstone, have proved to the satisfaction of me, Gathorne Hardy, one of Her Majesty's Principal Secretaries of State, that the said occupiers were employing at the time of the passing of the Factory Acts Extension Act, 1867, and had for not less than a year previously to such passing employed, young persons and women at night, and have further proved to my satisfaction that they cannot, without a considerable interval of time, alter their

machinery, so as to dispense with such employment: Now I, the said Gathorne Hardy, do by this, my Order, made in pursuance of the fifth Article of the Schedule of the Factory Acts Extension Act, 1867, authorize the employment by the said occupiers until the first day of June, one thousand eight hundred and sixty-nine, of young persons and women in such manner and for such times as have previously been customary in the said Paper Mill:

(No. 109.)—WEST INDIES—HONDURAS GULF.

*Fixed Lights on Mauger Cay*

THE Colonial Government at British Honduras has given notice, that lights have been exhibited from a lighthouse recently erected on Mauger cay, north of Turneffe islands, at the northern approach to Belize.

The lights are three *fixed* white lights facing to the N.E. and S.W., the two lower lights elevated 49 feet, and the upper light 53 feet, above the level of the sea. In clear weather they should be seen from a distance of 13 miles.

The illuminating apparatus is dioptric or by lenses.

The lighthouse is 57 feet high, and constructed of iron; the upper part is painted black and the lower part white. The lights can be seen above the trees from all points of the compass, but the lighthouse is seen from seaward alone from N.E. to S.W. by W. It stands in lat. 17° 37½' N., long. 87° 45½' West of Greenwich.

[All bearings are Magnetic. Variation 7° Easterly in 1868.]
