"SEA FISHERIES ACT, 1868."

*Board of Trade, Whitehall,

THE Board of Trade have received from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Ambassador at Paris, enclosing copy of a Note from the Imperial Minister of Foreign Affairs, stating that the French Government declare it to be impossible that the Convention relative to Fisheries, signed the 11th of November, 1867, between Her Majesty and the Emperor of the French, can be brought into operation until the prohibitions contained therein have been sanctioned by the Corps Legislatif; but that arrangements have been made in order that a law to that effect may be passed with as little delay as possible.

With reference to the notification published in the Gazette of the 22nd ultimo that the day fixed

for the coming into force of "The Sea Fisheries Act, 1868," was on the 1st instant, notice is hereby given, that the Convention above-mentioned, which is set out in the First Schedule to that Act, has not yet been brought into operation in the manner prescribed in the 39th Article thereof, and that until it has duly come into operation, so much of "The Sea Fisheries Act, 1868," as relates thereto does not apply to French subjects and French vessels.

*10th Foot, Lieutenant Theophilus Scott to be Captain, without purchase, vice John Dickson Power, deceased. Dated 23rd December, 1868. Ensign Eustace Beaumont Burnaby to be Lieutenant, without purchase, vice Scott. Dated 23rd December, 1868.*

*12th Foot, The surname of the Ensign appointed in the Gazette of the 1st December, 1868, is Hutton-Riddell, and not Hulton-Riddell, as then stated.*
