

**THE SANITARY ACT, 1866, AND THE  
SEWAGE UTILIZATION ACT, 1867.**

**ORDER FOR UNITING THE LOCAL BOARDS OF THE  
BOROUGH AND PARISH OF FALMOUTH, IN THE  
COUNTY OF CORNWALL.**

WHEREAS the Local Board for the Municipal Borough of Falmouth, in the county of Cornwall, and the Local Board for the parish of Falmouth, in the same county, have, after notice given in pursuance of the Sewage Utilization Act, 1867, applied to me, as one of Her Majesty's Principal Secretaries of State, for an Order forming the said districts into a United District for the purposes of the Sewage Utilization Acts, 1865 and 1867, or for any of such purposes.

And whereas I am satisfied of the expediency of such union. I do hereby order, in pursuance of the said Act, that the said districts shall be, and the same are hereby, and from the date hereof, formed into a United District for the purposes aforesaid, and that the joint Sewerage Board of the said United District shall consist of Twelve Members, of whom six shall be elected by the Local Board of the said parish, and six by the Local Board of the said borough, out of the Members of the said Boards respectively, and by the majority of the votes given at the meetings of the said Boards respectively, on the nineteenth day of February instant.

And the Members so elected from each Board shall continue Members of the Joint Board so long as they shall continue Members of such Boards respectively. And the first meeting of the said Board shall take place on Monday, the 22nd day of February instant, at the office of the Local Board for the said borough.

And in the event of any Member so elected dying, refusing to serve, resigning, or retiring before the expiration of his period of office, the vacancy so caused shall be filled up within fifteen days after the first meeting of the Board following the vacancy, by fresh election from the Members of the Board from which the Member so dying, refusing to serve, resigning, or retiring, was originally elected.

And the expenses incurred by the said Joint Sewerage Board shall be defrayed out of a common fund to be contributed by the Component Districts, in proportion to the rateable value of each district, and computed yearly.

**NOTICE TO MARINERS.**

(No. 11.)—AFRICA—SOUTH COAST—ALGOA BAY.

*Alteration in Cape Recife Light.*

THE Harbour Master at Port Elizabeth has given notice, that from the 1st day of December, 1868, the following alteration would take place in the light on Cape Recife, Algoa Bay:—

A ray of red light would be shown from the lighthouse between the bearings N. 39° E. and N. 12° E., as a guide to mariners on approaching Roman Rock.

*Directions.*—Vessels bound for Algoa Bay, after passing Cape Recife, should not come within the red ray of Cape Recife light until the Harbour light on the hill (which when first seen is red) is seen bearing N.W., but as the southern limit of the Harbour light passes only two cables northward of Roman Rock, it is recommended that a course for the anchorage should not be shaped until the red ray from the Harbour light is passed and the white light seen bearing N.W. by W.

[All bearings are Magnetic. Variation 29½° Westerly in 1869.]

*Wreck in Falmouth Harbour.*

NOTICE is hereby given, that the French brig *Charles Emma* now lies sunk in four fathoms at low water springs, about three quarters of a cable S.S.W. from the white (and west) buoy of the narrows of Falmouth harbour.

The wreck lies with the following bearings:—
