

established communication with the shore, repair to the central Custom-house at Stamboul, in order to conform to the formalities prescribed by Art. I. He can only come to an anchor off the Custom-house of Bagtché-Capon, of Galata, or inside the harbour if he has obtained special permission.

No vessel laden with foreign salt may be anchored off the coast between Kutchak-Tchekméde and the point of Sérial (with the exception of Yéni-Capon), or off the Iles des Princes, or the Asiatic coasts from the Gulf of Ismidt inclusive, to Scutari.

## ARTICLE III.

When a vessel overtaken by a calm, or any other stress of weather, shall not be able to come to an anchor at one of the anchorages fixed by the preceding Article, the master must, as soon as the state of the sea or his vessel will allow him, inform the Central Custom-house, at Stamboul; if the latter wish the vessel to be taken in tow, it can make it do so, but at its own expense, when the cause, however, no longer exists, if the master does not proceed to one of the prescribed anchorages the Customs' administration can have the vessel taken in tow, at the master's expense.

## ARTICLE IV.

Any infraction of the above regulations renders the master of a vessel liable to a fine of twenty Turkish livres, besides the costs of towing the vessel to one of the prescribed anchorages, or to the mouth of the Bosphorus. The vessel will not be allowed to proceed on her voyage, until the fine and the other expenses above mentioned shall have been defrayed.

## ARTICLE V.

The Consular authorities and the harbour masters of friendly powers will, it is hoped, lend the Customs Officers any assistance necessary to carry out the provisions contained in the present regulation.

The present regulation will come into force throughout the whole Empire one month after the date of its promulgation.
