# NOTICE TO MARINERS.

### (No. 16.)-FRANCE-NORTH COAST.

#### Alterations in Lights and Buoys.

THE French Government has given notice that, during the month of August, 1869, the following alterations in the lights and buoys between Calais and the Belgian frontier will take place.

#### LIGHTS.

The Snouw or Mardyck tight-vessel will be removed about one mile westward of its present

position, and near Snouw bank in 11 fathoms. Position, lat. 51° 3' 32" N., long. 2° 12' 35" East of Greenwich.

Dyck lights.—A light-vessel will be placed in 11 fathoms water,  $3\frac{1}{2}$  miles N. by W.,  $\frac{1}{3}$  W. from Gravelines lighthouse; from this vessel two fixed white lights will be exhibited, one elevated 34feet, the other 23 feet above the sea, and in clear weather they should be seen from a distance of 11 miles. The light-vessel will be painted *red*, and have a ball at each masthead.

Position, lat. 51° 3′ 8″ N., long. 2° 3′ 29″ East.

Ruytingen light-vessel will be removed to the northern part of Out Ruytingen bank, about a mile from the north-east extremity, in from 8 to 10 fathoms water, and N. by W.  $\frac{1}{4}$  W.,  $11\frac{1}{2}$  miles from Dunkerque lighthouse. Position, lat. 51° 12' 52" N., long. 2° 12' 9" East.

The names of each light-vessel will be painted in white letters on their sides.

Directions.—The Dyck lights in line with the revolving light of Dunkerque will indicate the direction to Dunkerque roads when coming from the westward.

The Snouw and Dyck lights kept in line will indicate the position of Dunkerque roads.

The Dyck light, when kept a little to the left, or to the eastward, of the fixed light of Gravelines, will lead through the passage between the western point of Out Ruytingen and the small bank to the westward of it.

As the exact date on which these alterations will be made cannot be given, caution will be necessary in navigating in the vicinity about the time proposed for the change to take place. If the light-vessels have been moved, vessels coming from the North and making for the
