

Llancarvan: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend of fifty-four pounds, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant to the Incumbent of the vicarage of Howden, in the county of York, and in the diocese of York, and to his successors Incumbents of the same vicarage, one yearly sum or stipend of one hundred and thirty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of November, in the year one thousand eight hundred and sixty-eight, and to be receivable in equal half-yearly portions on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Saint Mary Bishophill, Senior, York, in the county of York, and in the diocese of York, and to his successors, Incumbents of the same vicarage, all that plot or parcel of land and hereditaments, with the appurtenances thereunto belonging, more particularly described in the schedule hereunto annexed, and now vested in us, to have and to hold the said plot or parcel of land and hereditaments to the use of the said Incumbent and his successors for ever: Provided always, that the said plot or parcel of land and hereditaments shall be and be held to be in lieu of and in substitution for a portion, amounting to six pounds, of the annual sum of one hundred and twenty pounds, payable by us to the Incumbent for the time being of the said vicarage, under the authority of an Order of Her Majesty in Council, which was published in the London Gazette of the fourth day of April, in the year one thousand eight hundred and sixty-five: Provided always, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said plot or parcel of land and hereditaments as from the
