following; that is to say: "We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixteenth and seventeenth years of your Majesty, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of your Majesty, chapter one hundred and twenty-four, have prepared, and now humbly lay before your Majesty in Council, the following scheme for effecting an exchange of the patronage of the benefice (being a vicarage) of Oundle, situate in the county of Northampton, and in the diocese of Peterborough, the patronage of which benefice belongs to the Crown, and is exercised by the Lord High Chancellor of England for the time being, in virtue of his office, for the patronage of the benefice (being a rectory) of Harpenden, situate in the county of Hertford, and in the diocese of Rochester, the patronage of which said lastly-named benefice belongs to the Bishop of Peterborough, in right of his see.
