It is Her Majesty's command that no presentations shall be made at these Levees, except in accordance with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, and of every other power enabling them in this behalf, and under and in pursuance of The Consolidated Cattle Plague Order of August, 1867, do hereby define the following part of the port of North Shields, in the county of Northumberland, as a part thereof, within which foreign cattle may be landed (that is to say):—

All those premises situate between the river Tyne and a street called Clive-street, in the township of North Shields, in the borough of Tynemouth, in the county of Northumberland, consisting of a wharf or landing-place, warehouses, offices, and dwelling-rooms belonging to the Shields Steam Shipping Company Limited, and in the occupation of the said Company, Luigi Descalzo, Emanuel Descalzo, William Moor, Bridget Cartman, John Combs, and others, and also of a slaughter-house belonging to Ann Wilson, of North Shields aforesaid, Outfitter, and now unoccupied, and also of a Boat Builder's shop belonging to the said Shipping Company, and now unoccupied.

All which said premises are bounded on or towards the south-west by a steam flour mill, in the room of I offices, and tenements or dwelling-rooms belonging Cartwright, resigned.

- 1. All foreign cattle landed within the said defined part of the port shall be slaughtered within that defined part, within ten days after the landing thereof, exclusive of the day of landing.
- .2. Cattle other than foreign cattle within the said defined part shall not be removed therefrom alive.
- 3. The Order of Council of the eleventh day of October, one thousand eight hundred and sixty-seven, defining the part of the port of North Shields within which foreign cattle might be landed is hereby revoked.
