

diocese of Salisbury (in testimony of which consent they the said several consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of East Knoyle, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint John the Baptist, situate at Hindon aforesaid, and that the same should be named 'The District Chapelry of Saint John the Baptist, Hindon.'

"And, with the like consent of the said several consenting parties (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint John the Baptist, Hindon, being:—

"All that part of the parish of East Knoyle, in the county of Wilts, and in the diocese of Salisbury, which is comprised within and is co-extensive with the limits of the reputed chapelry or township of Hindon."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Salisbury.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King

George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-second day of April, in the year one thousand eight hundred and sixty-nine, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council the following representation, as to the assignment of a district chapelry to the consecrated church of Saint Asaph, situate in the parish of Saint Thomas, Birmingham, in the county of Warwick, and in the diocese of Worcester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Asaph, situate in the parish of Saint Thomas, Birmingham aforesaid.

"Now, therefore, with the consent of the Right Reverend Henry, Bishop of the said diocese of Worcester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Saint Thomas, Birmingham, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Asaph, situate in such parish, and that the same should be named 'The District Chapelry of Saint Asaph, Birmingham.'

"And with the like consent of the said Henry, Bishop of the said diocese of Worcester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend Charles Thomas Wilkinson, the present rector or incumbent of the rectory of the said parish of Saint Thomas, Birmingham, shall continue to be such rector or incumbent, all the fees which may be received in respect of such publication, solemnization, or performance as aforesaid, shall be paid by the minister of the said church of Saint Asaph, to the said Charles Thomas Wilkinson: And provided also, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.
